3. Minute of the last meeting - 10 June 2009

4. Matters arising

5. Minutes of the last Steering Group meeting – 15 June 2009

5.1 It was reported that item 7.3 of the minute had not been progressed as Ken Grant and James Stockan were unable to meet Skills Development Scotland however that Anna Whelan had done so in their absence.

7. Fairer Scotland Fund

7.1 Concerns were expressed regarding the timescales of a decision yet to be made by the Council with regard to the distribution of funds. The group asked that this item remain on the agenda and their concerns be elevated to the Steering Group.

8. SOA summary

Volunteers who are able to demonstrate creative use of FSF are encouraged to consider submitting a project as a good practice example. Support will be available from the Community Planning Officer.

11. Community Planning Partnership review

11.1 Maintaining information (minutes from thematic groups, changes to groups etc)

The group agreed that minutes should be submitted to the Community Planning Officer on a voluntary basis, to encourage better communication.

It was agreed that the PLG is at a manageable size at present although becoming much larger may have a negative effect on the efficiency of the group and therefore this should be taken into consideration should more thematic groups request representation on the PLG.

11.3 Thematic group updates

The group were of the view that in the past when all thematic groups provided updates it has been interesting however the time had eaten into the meeting business. It was agreed that rather than have a full update from all groups at each meeting, two groups would provide verbal updates to the group. Updates at the October meeting of the PLG will be from the Employability Strategic Group and from the Alcohol and Drugs Partnership regarding Primary Care Changes in Healthy Communities.

- 12.2 The signing of the OCPP Single Outcome Agreement time rescheduled and was to be held on 26 August 2009 at 1pm.
- 12.3 Gillian Morrison noted that Eileen Linklater had left post within the Council. She made significant contributions to Community Planning and the Single Outcome Agreement and the Partnership's thanks were noted.
