## **Structure Governance & Management**

#### Constitution

The charity is an unincorporated association. It is governed by its constitution which was adopted on 06 March 2012. The association was granted charitable status by OSCR on 29 November 2012 (unless we have adopted the new SCIO constitution prior to the AGM taking place)

#### **Appointment of Trustees**

In accordance with the constitution the management committee is made up of trustees and there must be a minimum of 4 elected trustees to take up the roles of Chair, Vice-Chair, Secretary and Treasurer. (this will be 3 under the new SCIO constitution) The committee may co-opt further trustees if they consider it to be in the interest of the association. The management committee were elected at the AGM (conducted remotely due to Covid-19) on xx xx 2020

A communication is sent to all residents approx. three weeks before the AGM to ask if any residents would like to become Trustees and / or be considered for election for one of the committee roles.

## **Changes to Trustee**

There were no changes to the Trustees – all stood down and were re-elected

#### Management

The trustees are responsible for the running of the association and managing the community facility. The day to day running of the association is carried out on a voluntary basis by the committee.

# **Objectives and Activities**

#### **Charitable Purposes**

The provision of recreational facilities, or the organisation of recreational facilities, with the object of improving the conditions of life for the persons for whom the facilities or activities are primarily intended

#### **Activities**

Our activities are primarily based around retaining a community facility for the benefit of all residents and visitors to Egilsay. This includes

- Repairs, cleaning, maintenance and decoration of the community building
- Liaising with Orkney Islands Council for repairs to the fabric of the building and the main utilities which remain the responsibility of Orkney Islands Council
- Taking responsibility for the community turbine its maintenance and repair and managing the revenue created through the FITs payment scheme
- Provision of equipment for the purpose of leisure and recreational activities
- Holding community social events
- Assisting residents to access health, education and recreational activities on our neighbouring islands and on Orkney mainland e.g. provision of ferry tickets for sports / theatre/pantomime / well-being courses/Seasonal events/music/training courses that cannot be provided on the island.
- Partnership working with other organisations to arrange events and enhance facilities on Egilsay
- Ensuring appropriate insurance and licences are in place.
- Holding committee meetings as appropriate and the AGM

#### **Achievements and Performance**

Note: from 20 March 2020 COVID 19 restrictions came into force which effectively put everything on hold – the notes below reflect activities up until that time.

- 1. Travel assistance for permanent residents helping with ferry/bus/taxi fares to attend facilities outwith Egilsay.
- 2. Each household with permanent residents were allocated £200 to assist with cost of travel.
- 3. Egilsay Community produced leaflets that advertise the community facility to locals and visitors alike these are placed on the boat the Tingwall waiting room, Travel Centre Kirkwall and various outlets on Rousay.
- 4. We have seen a significant increase in tourists this year and there are many positive and appreciative comments entered into our visitors book this is due to the launch of the Egilsay leg of the St Magnus Way, continued events arranged by RSPB and a general increase in the number of visitors to Orkney

- 5. We continue to work in partnership with the RSPB who continue to maintain a significant presence on the island and have had several organised groups visit this year who have been welcomed to our community facility.
- 6. The remaining funds from YIYC Round 2 were spent in the following categories

  \*Promoting Egilsay\* New promotional materials, rack cards posters etc and to hold and an Archaeology day working with UHI Archaeology Institute in Orkney

  \*Egilsay Recreation travel and welfare fund\* to assist with travel for health services, recreation and amenities and essential supplies

  \*Looking after our facility\* to help with payment of keeping our community facility clean, tidy and stocks replenished

The community facility is used for events and functions, committee meetings and the AGM as well as hires to RSPB and other visiting groups. We have welcomed numerous independent walkers and several repeat visitors. We have facilitated several St Magnus Way events and the table below summaries the main events that have taken place 01 June 2019 to 31 May 2020

# **Community Facilities**

During this period Egilsay Community Association have also entered into discussions (that are ongoing) with Orkney Islands Council and Voluntary Action Orkney to establish a way forward to purchase the School House and School building so that they can be secured as a facility for the future benefit of the Egilsay Community. The lease between Orkney Islands Council and Egilsay Community Association for the current school building expires in 2021 and OIC have expressed the view that they are seeking a transfer of ownership rather than to carry on as Landlord.

In order to take on this responsibility and after advice from Voluntary Action Orkney, ECA agreed to convert to a SCIO (Scottish Charitable Incorporated Organisation) and adopt a new constitution

ECA committee are at the time of writing in the process of coverting to a SCIO and a new constitution has been prepared and agreed. The application and associated documentation will be submitted to OSCR during September 2020

#### **Community Turbine**

Since the major repairs that were completed in May 2017 the turbine has been up and running with no identifiable issues. The turbine undergoes annual maintenance checks from Pure Energy Centre – Shetland.

It was noted that at around February time the turbine production output was not being recorded and therefore revenue was lost. Bad storms meant that the team from Shetland couldn't here and this was closely followed by the COVID-19 lockdown meaning the turbine service didn't happen until July – although the service was completed recording of turbine output remains in doubt and is being monitored.

Hire Rates for the Hall – these remain unchanged and are as follows

The Main Hall (groups up to approx. 40 people) £25 per hour The Classroom (groups up to approx 12 people) £15 per hour The Main Hall and Classroom together £30 per hour

Repairs

No major repairs have taken place at the community hall this year  $\,$  - 5 grass cuts took place at both the school and school house

#### Cleaning

The hall is checked and cleaned regularly and stocks of consumables and cleaning materials are purchased as required

#### **Toilet Facilities**

The number of large groups experienced over the last couple of years highlighted the need for the old school toilets at the back of the building to be refurbished. They are functional with a cold-water supply but the sanitary ware needs replacing and the outbuildings need to be made weathertight and re-decorated. Decisions on this have been put on hold due in part to COVID 19 and also pending the outcome of the transfer of ownership

#### **Outside Tap**

It was agreed that as well as the new bin storage area and an outside tap should be installed at the Egilsay Pier waiting room. This would be beneficial for washing salt of cars and washing out the large commercial waste bins ECA have presented the quote to the Community Council who have agreed to go 50/50 on costs with Egilsay Community Association – this work was also put on hold during COVID 19

#### Heating

It was agreed that the large, old heater should be removed from the hall as it is no longer fit for purpose and is taking up valuable space. This will be replaced with more suitable end efficient heating, quotes have been requested - this work was also put on hold during COVID 19 it is hoped that is work can be carried out before winter 2020/2021

#### **Financial Review**

#### Payments to individuals (including charity trustees and connected persons)

As part of our application to become a charity we informed OSCR that ECA intended to pay nominal amounts to inhabitants of Egilsay for work undertaken at the community facility on the Associations behalf. A population of 20, living on a very small remote island, by definition everyone is connected.

It was agreed that it was important to get work done by the community for the community avoiding the high costs of importing labour from mainland Orkney.

It was agreed at the AGM 17 July 2012 that to complement the voluntary work already undertaken nominal payments for small jobs on an ad-hoc basis was acceptable on the following grounds.

Work is undertaken on behalf of the community and for which the association is responsible. E.g. grass cutting, Decorating and maintenance, cleaning, book-keeping/accounts and ad-hoc requirements decided and agreed by the committee.

Work can be carried out on a self-employed basis payable on invoices received.

All monies paid will be recorded in the Egilsay Community Association accounts. Paid work will be minuted and a summary presented in the Trustees Annual Report and at each AGM

#### Reserves

The trustees policy is to retain sufficient funds to cover its leasehold responsibilities to Orkney Islands Council such as ad hoc maintenance, internal repairs and decoration and on going liabilities such as turbine maintenance, insurance, licences, telephone and broadband and the annual fee for the Orkney Communities website and independent examination of accounts. The trustees also wish to retain sufficient funds to repair or replace equipment owned by the association. Around £5000 held as a reserve is thought to be a realistic amount to cover this.

#### Plans for future periods

The trustees plan to maintain and develop the facility for the benefit of the community and will actively seek suggestions for the next stage in revitalising and rejuvenating our community facility. The wooden floor in the hall was refurbished during January 2019 and we hope to progress with upgrading the old school toilets at the back of the main building and to install suitable heating to the hall. The main focus over the coming months will be to continue discussion and negotiation with OIC over the future of the school and school house before the current lease expires in 2021.

*Egilsay School House* – Following on from previous meetings and discussions held with representatives of OIC and VAO, Communications and negotiations are continuing with OIC. We are waiting for a formal proposal of options from Orkney Islands Council and are in the process of converting to a SCIO. (Scottish Charitable Incorporated Organisation)

We will continue to consult with OIC, VAO and other parties to develop this project through the coming year.

**St Magnus Way** — The way markers, information boards and stone sculptures were installed last summer ready for the official opening of the Egilsay leg of The St Magnus Way. Unfortunately COVID 19 restrictions meant that visitors could not visit from March to July 2020 but the hope is that the St Magnus Way will again encourage walkers who have an interest in St Magnus and provide a legacy for the future. <a href="https://www.stmagnusway.com/">https://www.stmagnusway.com/</a>

**Partnership working** - We plan to develop partnership working with Rousay School, RSPB, The Rousay, Egilsay & Wyre Heritage Trust, REWDT, St. Magnus Way, OIC and other interested parties with a view to promoting Egilsay as a place to visit and facilitating various interests and events for visiting groups.

#### Independent Examiners report to the Trustees of Egilsay Community Association
