

Structure Governance & Management

Constitution

The charity is an unincorporated association. It is governed by its constitution which was adopted on 06 March 2012. The association was granted charitable status by OSCR on 29 November 2012

Appointment of Trustees

In accordance with the constitution the management committee is made up of trustees and there must be a minimum of 4 elected trustees to take up the roles of Chair, Vice-Chair, Secretary and Treasurer. The committee may co-opt further trustees if they consider it to be in the interest of the association. The management committee were elected at the AGM held on **14 October** 2017 at the Community Hall.

A communication is sent to all residents approx. three weeks before the AGM to ask if any residents would like to become Trustees and / or be considered for election for one of the committee roles.

Changes to Trustees

Barry Jackson has moved from Orkney (June 17) and is no longer a Trustee. Edwin Dick has stepped in as vice chair until new office bearers are elected at the next AGM.

Objectives and Activities

Charitable Purposes

The provision of recreational facilities, or the organisation of recreational facilities, with the object of improving the conditions of life for the persons for whom the facilities or activities are primarily intended

Activities

Our activities are primarily based around retaining a community facility for the benefit of all residents and visitors to Egilsay. This includes

- Repairs, maintenance and decoration of the community building
- Liaising with Orkney Islands Council for repairs to the fabric of the building and the main utilities which remain the responsibility of Orkney Islands Council
- Taking responsibility for the community turbine its maintenance and repair and managing the revenue created through the FITs payment scheme
- Provision of equipment for the purpose of leisure and recreational activities
- Holding community social events
- Assisting residents to access health, education and recreational activities on our neighbouring islands and on Orkney mainland e.g. provision of ferry tickets for sports / theatre/pantomime / well being courses/Seasonal events/music/training courses that cannot be provided on the island.
- Partnership working with other organisations to arrange events and enhance facilities on Egilsay
- Ensuring appropriate insurance and licences are in place.
- Holding committee meetings as appropriate and the AGM

Achievements and Performance

Egilsay Community Association submitted the following grant application to Your Island Your Choice and successfully received £2308. Two projects were submitted

- 1. Travel assistance for permanent residents helping with ferry/bus/taxi fares to attend facilities outwith Egilsay.
- 2. Assistance with promotional material (digitised logo + postcards, folded cards + rack cards) + assistance with MAGNUS 900 events

Each household with permanent residents were allocated £200 to assist with cost of travel. Egilsay Community produced leaflets that advertise the community facility to locals and visitors alike these are placed on the boat the Tingwall waiting room, Travel Centre Kirkwall and various outlets on Rousay. The digitised logo can be used on all documents, publications and website etc. Postcards and folded cards were produced for the MAGNUS 900 anniversary year. The remainder of funds were used to supply consumables and catering aids for the significant number of visitors / pilgrims attending MAGNUS 900 events on Egilsay.

We have seen a significant increase in tourists this year and there are many positive and appreciative comments entered into our visitors book – the increase has been largely to do with events surrounding MAGNUS 900 as well as the overall increase in tourists to Orkney

The RSPB continue to maintain a significant present on the island and have had several organised groups visit this year. Work continues at Onziebust and RSPB activity has significantly increased usage of the ferry service.

The community facility is used for events and functions, committee meetings and the AGM as well as hires to RSPB and other visiting groups. We have welcomed numerous independent walkers and several repeat visitors. We have facilitated several MAGNUS 900 events and the table below summaries the main events that have taken place 01 June 2016 to 31 May 2017

Community Facilities

Community Turbine

The Community Turbine was taken down on 11 March 2017 due to a serious fault. The turbine was out of action for approx 2 months whilst parts were made to enable repair. The turbine is now up and running. The maintenance and repair bills were £240 + £4166 a significant outlay but one that was necessary. A financial request was made to the Rousay, Egilsay, Wyre and Gairsay Community Council (REWGCC) for financial assistance and ECA

were awarded £1000 and paid on 12 June 2017 (next financial year) to assist with Turbine repair costs. The work was completed in May and a full report provided. The turbine is now up and running with no apparent issues to date.

Hire Rates for the Hall

The Main Hall (groups up to approx. 40 people) £25 per hour The Classroom (groups up to approx 12 people) £15 per hour The Main Hall and Classroom together £30 per hour

Water

We have recently been served with a Boil Notice after water sampling by OIC Environmental services – we are waiting for further information and advice from OIC.

Toilet Facilities

The number of large groups experienced this year highlighted the need for the old school toilets at the back of the building to be refurbished. They are functional with a cold water supply but the sanitary ware needs replacing and the outbuildings need to be made weathertight and re-decorated.

Financial Review

The main expense outweighing any other was the Community Turbine Repair at £4406

Other significant expenses relating to charitable activities included purchase of 50 passenger ferry tickets for each permanent resident £1117.50

Restricted funds -

£2308 was received from the Tour Islands Your Choice fund and this was used to assist permanent residents with the cost of travel to access services outwith Egilsay (£1533.00), promotional material consumables and help towards catering equipment and supplies for MAGNUS 900 events (£775.00) This financial year - £2026 has been spent

All of the funds under this grant have now been spent and the project has ended. (Receipts reported in the next financial year for the remaining £282)

Unrestricted funds

General expenditure in this financial year has been attributed to maintenance of the facility including turbine maintenance and repairs £4405.52, telephone and broadband payments £566 renewal of TV licence £150.50 public liability £382.00, grass cutting £180, book keeping and preparation of accounts and Trustees Annual Report £150 and paying the Orkney Communities website fee £45.00

ECA bought books of passenger tickets for every permanent resident on the island £1117.00 ECA also contributed £130 for the purchase of medical equipment recommended by our local GP and is located at the community hall. Other items purchased were a Henry Hoover £112.00, and a new coffee urn £165 and £200 was spent on Fireworks.

Sundry consumable items such as printer ink and paper and bottled water, tea, coffee, milk, biscuits, and providing refreshments for several large groups of visitors made up the remainder of expenditure.

Reserves

The trustees policy is to retain sufficient funds to cover its leasehold responsibilities to Orkney Islands Council such as ad hoc maintenance, internal repairs and decoration and on going liabilities such as turbine maintenance, insurance, licences, telephone and broadband and the annual fee for the Orkney Communities website and independent examination of accounts. The trustees also wish to retain sufficient funds to repair or replace equipment owned by the association. Around £5000 held as a reserve is thought to be a realistic amount to cover this.

Plans for future periods

The trustees plan to maintain and develop the facility for the benefit of the community and will actively seek suggestions for the next stage in revitalising and rejuvenating our community facility. We hope to progress with upgrading the old school toilets at the back of the main building, decorating the toilet and entrance area in the main building and to clear out the old office and use as a Community Association office.

Egilsay School House – Following an announcement earlier this year – OIC have agreed to sell/lease the Egilsay School House to Egilsay Community Association. We are currently waiting for a formal proposal of options from Orkney Islands Council. Luke Fraser - Housing Manager (Policy & planning) is looking into this for us and we hope to have an update on this before the end of the calendar year. This will represent a significant amount of work as changes to the structure of the organisation and grant funding applications will be required.

St Magnus Way — Rousay, Egilsay & Wyre Development Trust (REWDT) have funded Way markers, stone sculpture and information boards. These will be installed to promote Egilsay as an addition to the main St Magnus Way on mainland Orkney (this is illustrated on our rack cards). This will encourage walkers who have an interest in St Magnus and provide a legacy after the MAGNUSS 900 year has finished.

Partnership working - We plan to develop partnership working with Rousay School, RSPB, The Rousay Egilsay & Wyre Heritage Trust, REWDT, OIC and other interested parties with a view to promoting Egilsay as a place to visit and facilitating various events for visiting groups.

We will pursue further income streams via grant funding such as the Scottish Land Fund to realise the potential of any future project for the School House for the benefit of the community. A condition of funding for this type of project will mean changing our constitution from an unincorporated charity to either a Scottish Charitable Incorporated Organisation) (SCIO) or a Community Interest Company (CIC) which will provide a degree of protection against individual liability and allow a different management structure.

However, there are important differences between unincorporated and incorporated organisations and Egilsay Community Association will take expert advice before taking further action.
