Structure, Governance and Management

Constitution

The Charity is a Scottish Charity, which was set up in 1959, and which was in operation for over 50 years as an unincorporated association. At the 2013 AGM, the charity made the decision to change its legal form to a Scottish Charitable Incorporated Organisation (SCIO). The proposed SCIO constitution received approval by OSCR on 25th February 2014, and asset transfer to the SCIO (which wound up the unincorporated association) occurred nearly 18 months later, on 2nd July 2015. This annual report and accounts are thus for the sixth full year after the charity became a SCIO. The charity had a single tier structure and as such the trustees were the members of the charity.

Appointment of Trustees

The charity is a membership organisation. Any member of the charity can stand for election as a trustee, and trustees are elected at the Annual General Meeting.

Objectives and Activities

Charitable Purposes

The advancement of education, the advancement of environmental protection or improvement. To promote the study and conservation of the natural heritage of the County by means of:

- field projects and expeditions
- lectures, demonstrations, exhibitions and films
- publications; liaison with voluntary or statutory organisations with allied interests
- fund-raising
- any such activity as may be lawful and conductive to the attainment of the aim.

Activities

The Club runs a wide range of walks and wildlife-recording events through the year. The Club will organise or support events to increase knowledge and understanding of local wildlife, and to improve wildlife identification and recording skills.

The Club liaises with other organisations and is actively involved with the Orkney Wildlife Information & Records Centre.

The Club also makes representations on conservation issues, particularly to Orkney Islands Council regarding planning matters.

The Club has a range of wildlife-recording sub-groups. Currently these cover marine wildlife, flora, bats and dragonflies.

The Club would normally run club nights from autumn through to early spring, which usually take the form of an illustrated talk. All club events are open to all, subject to any limit on numbers for particular events, and when a fee applies, the fee will be reduced for members as opposed to non-members

The Club publishes a newsletter for its members three times a year.

The Club also publishes an annual Bulletin: The Orkney Naturalist. This is a journal of record, containing reports by county recorders for their respective wildlife groups, along with a wide range of articles relating to the wildlife of Orkney. The Bulletin is available free to members and is also offered for sale.

The Club set up a native tree plantation at Durkadale in Birsay nearly 30 years ago. This is currently leased from the RSPB and now supports a thriving range of native tree species and provides valuable wildlife habitat.

The Club offers small (under £500) grants to members for research projects.

Achievements and performance

For the early period of this report (1 April 2021 up to 31 March 2022), the Club was curtailed by Covid restrictions leading to the cancellation of our New Year and Winter/Early Spring outings and indoor talks. The club embraced meeting via zoom in April and May and held talks covering Arctic Skuas, Day flying Moths and Butterflies, Bumblebees, and Dragonflies and Damselflies. Virtual talks made it possible for a wider audience to attend. We welcomed Orkney Outer Isles residents, folk from Wester Ross and even from Southern England.

In June we organised a BioBlitz weekend. Instead of limiting it to participants' gardens (as in 2020) we suggested people visit their favourite 'local' patch for close study and to get in the habit of recording. We would like to thank our volunteer team of experts who helped with identifications and everybody who took part.

As restrictions in the summer eased the Club was able to undertake several Flora excursions throughout Orkney. We also ran a moth trapping and identification event. Members joined with Outer Isles residents for two days of bryophyte study; we would like to thank the Papay community for welcoming us and for support from North Isles Landscape Partnership Scheme.

In September we held a Bat detection Evening in Finstown led by the County Bat Recorder. In October we held our AGM, giving members opportunity to respond by email or by post. A new Committee was later elected.

In the autumn we held talks covering Life beneath the Sea and Carder Bees. Poor weather forced the cancellation of our November Atlantic Grey Seal pup viewing trip. Our last outdoor event of the year was a Moss identification event at Binscarth.

The Club sent representatives via zoom to various groups e.g. the local access forum, and various consultative bodies.

The Club was active in supporting the Orkney Wildlife Information & Records Centre which sadly closed in Summer 2021

The Club continued to produce regular newsletters and to maintain a website and Facebook page. The 2021 Bulletin kept up to the high standard which is now expected of this publication. It was printed and distributed within this period, in summer 2021.

There were no applications for small grants to members for research projects during the period.

Financial Review

The Club continues to be in a strong financial position. The Club made a surplus of £827.10 over the period. There were no exceptional items to influence the financial position this year. The strength of the Club's financial position and the lack of face-to-face meetings and events meant there was no need to raise the membership subscriptions. A claim for Gift Aid over recent years remains to be made, which will benefit the financial position.

Reserves Policy

The Club is committed to holding sufficient funds to meet forthcoming commitments such as Bulletin and newsletter production and the necessary governance and insurance costs. The Club's financial reserves of £20,349.37 are more than sufficient for this at present.

Future Plans

The Club has a well-established pattern of activity which remains appropriate and which it is committed to continuing. The Club will respond to conservation issues as required and will continue to look for opportunities to engage people with Orkney's wildlife. However, all indoor meetings have been cancelled for the foreseeable future due to the current virus situation, indoor meetings have been replaced with online talks and outdoor events have now restarted.

Notes to the accounts for the period ended 31st March 2022

1. Basis of accounting

These accounts have been prepared on the Receipts and Payments basis in accordance with the Charities & Trustee Investment (Scotland) Act 2005 and the Charities Accounts (Scotland) Regulations 2006 (as amended).

2 Nature and purpose of funds

The trustees maintain a single unrestricted fund for the day-to-day running of the club. At present, the Club holds no restricted funds.

3 Related party transactions

No remuneration was paid to the trustees or any connected persons during the period.

4 Interest

The Ecology Building Society applies interest to OFC's account on the 31st December of each year.

5 Club nights

There were no club night meetings due to the Covid 19 pandemic and restrictions.

6 Online costs

None in previous year, payment was delayed until this year.

7 Insurance

Insurance is brokered with TCV. Insurance premium (£79.80) was paid online but not claimed back during this year.

8 Membership Award Scheme

There were no awards this year.

9 Other expenditure

Voluntary Action Orkney subscription.

10 Total balance as at 31st March 2022

Accounting periods follow an annual April to March pattern from 2016/17 onwards.

11 Depreciation of equipment

The charity trustees considered it appropriate to depreciate the laptop & digital projector bought with a grant (restricted fund) in March 2012, over 5 years. The original value was £1079 and a fifth of this sum was written off on each anniversary of this date. Therefore, the value was written off to zero in March 2017.

No other equipment owned by the Club is considered to have a value which is sufficiently material for it to be represented in the accounts of the charity.
