- The scheme to promote Stronsay it is anticipated that the Stronsay website will be up and running very soon, along with the launch of a new tourist brochure.

#### **Housing Needs - Questionnaire**

### **Housing Needs – Forthcoming Presentation**

A community presentation and consultation on the purpose built housing for the older residents is to be arranged by the CDO. This will be an opportunity for the community to share their views. It will aim to outline the proposed housing development with maps, building plans and photos of the sites which have been offered to the community. OIC's Housing Manager Luke Fraser has accepted an invitation to attend the presentation.

### **Enterprise Zone**
