Apologies Tom Champagne, David Melbourne.

A special meeting was convened to discuss the planning application for 2 turbines at Ore Brae.

It was explained that the bank had insisted we object on the grounds that the turbines would take wind from the community turbine and graphs produced by the turbine company proved that this could be 4 to 5 percent.

The turbines were not the industry standard distance away and turbulence would also after the community turbine.

It appeared that the turbines had been sited to maximize their wind collection with no thought to the effect that would have on the community turbine.

It was proposed by John Challoner seconded my Lindsay Hall and agreed by those present that we should object on the grounds that the turbines should not be erected until recompense was agreed and legally documented.

It was also agreed that the references to the community benefit could be misleading, and people were already asking if the turbines were linked with the community turbine.

It was decided that a letter clarifying the position should be sent to the Orcadian and signed on behalf of all the directors by Terry and Max in their position as chair person of the two organizations. i.e. IHDT and HE.
