CaMPA Constitution

Introduction

- 1. The name of the Association shall be the "Campervan and Motorhome Professional Association" (referred to in this constitution as " CaMPA".
- 2. CaMPA was established on 22nd July 2010.
- 3. CaMPA has the following mission statement:

"The Campervan and Motorhome Professional Association will act as the representative body for the UK campervan and motorhome sector. We will promote best practice and provide confidence to customers that members have signed up to follow an agreed set of CaMPA guidelines"

Objectives

- 4. CaMPA shall have the following objectives
 - a) To be a central representative body to put the views of the campervan and motorhome industry to the general public and key stakeholders such as local councils, police forces, campsite owners and tourism agencies.
 - b) To help create a sustainable future for the campervan and motorhome industry by communicating with users on wild camping principles, safe driving practices and environmental awareness.
 - c) Promoting and sustaining the campervan and motorhome industry both within the UK and overseas to generate economic prosperity in rural areas and by recognising tourism demand throughout the year.
 - d) To set a series of quality standards covering vehicle safety and maintenance, insurance provision and customer complaints.
 - e) To provide a forum for the exchange of non-competitive information and foster links with trade organisations to provide member benefits.

Membership

 Membership of CaMPA is available to companies involved in the campervan and motorhome industry. This includes hire companies, sales companies and conversion companies. Membership is at the discretion of the Executive Committee. See Appendix 1

Associates

6. The Executive Committee shall, at its discretion, admit as an associate of CaMPA any organisation that is not directly involved in the campervan and motorhome industry but which is otherwise interested in the industry. Associates shall be entitled to receive most publications and other literature prepared under the auspices of CaMPA, and otherwise be entitled to participate in the affairs of CaMPA as decided by the Executive Committee.

Finance of CAMPA

7. The financial year of CaMPA shall be the 1st January to the 31st December but this may be changed by resolution of the Executive Committee.

- 8. The subscription scale shall be set by the Executive Committee.
- 9. Members and Associates shall pay an annual subscription fixed by the Executive Committee. See Appendix 2

Meetings of CAMPA

10. CaMPA shall hold an annual general meeting not later than four months after the end of each financial year. At least 10 members of CaMPA, or the Executive Committee, may at any time require the Secretary to convene a general meeting of CaMPA. In convening such a meeting the Secretary shall give not less than 21 days notice to members.

Executive Committee

- 11. The affairs of CaMPA shall be directed by an Executive Committee comprising
 - a. A minimum of five members elected on a national basis, each member serving for a two year term. Each member shall have as many votes as there are vacancies. The Executive Committee may make bye-laws governing the conduct of elections including provision to phase retirements.
 - b. No more than three members co-opted by the Executive Committee.
 - c. See Appendix 3 for member details
- 12. Each member of the Executive Committee shall have one vote. The President shall have a second, or casting, vote in the event of equality.

President and Deputy President

13. The Executive Committee shall, at its first meeting in each financial year, elect a President to hold office until the first meeting in the following financial year. The Executive Committee shall also elect a Deputy President. No person may hold the office of President, or of Deputy President, for more than two consecutive years. In the event of the President or the Deputy President resigning or ceasing to be a member of the Executive Committee, the Committee shall have power to elect a replacement to serve for the remainder of the term, this period of office not counting for the purpose of the requirement in the previous sentence. Current office bearers are detailed in a separately published list.

Publicity

- 14. CaMPA shall publish an annual report on its activities and a list of subscribing members. Both these documents will be published on CaMPA's website with the membership list being always up to date.
- 15. CaMPA's website domain will be www.campa.org.uk

Committees and Panels

- 16. The Executive Committee may establish and maintain sub-committees and project groups, and may delegate matters to them.
- 17. The Executive Committee may appoint technical panels to advise and assist it.

Delegation

18. The Executive Committee may delegate any of their powers.

Revision of the Constitution

19. This constitution shall be amended by CaMPA, provided that at least 75% of the members of CaMPA present at the meeting vote in favour of amendments of which prior notice has been given.

Method of operation

- 20. Given the geographical spread of CaMPA members, communications will predominantly be via email and telephone rather than a reliance on face to face meetings. Efforts will be made to convene on a minimum yearly basis.
- 21. AGM or EGM will be notified via email.
