Public Consultation - Change of Service

I am writing to let you know that we are proposing to change the opening hours of the above Post Office branch.

A recent review of Scotstoun Post Office has confirmed that fewer customers are now using this service than previously which means that the service is not sustainable for our Postmaster or Post Office Limited. I am sure you will appreciate this is the case in many locations as more customers access our services at other places and make more use of the internet.

It is important that the service is viable if we want to maintain local access to Post Office services and we are therefore proposing to change the opening times of the service to Monday to Friday 08:30 – 18:00, Saturday 09:00 – 17:00 and Sunday Closed. These changes have already taken effect. We are confident that the new opening times will adequately meet the needs of the Scotstoun community.

Our priority is to safeguard Post Office services to the local community. The reduction of opening hours at this branch presents the best possible solution to allow us to achieve this in the longer term having looked at a range of information specific to the local area before putting our plans into consultation.

Consulting on the change

We're now starting a local public consultation and we would like to hear your views on the following areas:

- Do you have any comments about the proposed opening hours
- Are there any other local community issues specific to Scotstoun which you believe could be affected by or affect the proposed change

Full details of the proposed new service are provided at the end of this letter. If you have any comments or questions, please email or write to me via our Communication and Consultation team, whose contact details are below. Any information we receive will be considered as we finalise our plans for the new service. If others in your organisation are interested in the proposal, please feel free to let them know about it. Please note that your comments will not be kept confidential unless you expressly ask us to do so by clearly marking them "In Confidence".

I've included information about the Code of Practice which sets out how we communicate and explain changes to the Post Office network at the end of the letter.

As we aren't looking to move this branch, some of the questions won't be applicable but full instructions are given at the start of the questionnaire. Dates for local public consultation:

Local Public Consultation starts	29 June 2017
Local Public Consultation ends	17 August 2017

In this instance we have extended public consultation by one calendar week to allow for the summer holiday period.

In order to maintain a Post Office service to our customers in Scotstoun, the branch is already operating the new opening hours. However, this does not affect the period of public consultation which is ongoing until 17 August 2017. At the end of the consultation period I will review any feedback received from our customers and local representatives, following which I will write to you again confirming the final service offer.

Thank you for considering our proposal. Posters and leaflets will now be displayed in branch to let customers know about the changes and to ask their views. At the end of the consultation I'll be in touch again to let you know our final plans.

Code of Practice for changes to the Post Office® network

What's a Code of Practice?

The Code of Practice contains guidelines we follow. They tell us how, and when to tell you about changes to your local Post Office services. We've worked with the independent statutory consumer watchdog on these guidelines, which in Great Britain is Citizens Advice and Citizens Advice Scotland, and in Northern Ireland, the Consumer Council.

What kind of changes does it include?

Information about when we're planning to move or close one of our branches or outreach services. This also covers information about when a branch has suddenly closed unexpectedly because of something like a flood or fire.

Who do we tell about changes?

You and your representatives (who are often local MPs or local authorities and councils).

How will we tell you what's happening?

If there's a minor change – like changing opening times, then we'll let you know by putting up posters in the Post Office. If the plan is to move a Post Office then we'll put up posters and hand out letters in the branch as well as writing to your representatives. We'll have a press release and, the relevant information will be easy to find on our website.

How long will it take?

We'll let you know about any changes as soon as we possibly can. Sometimes, change is out of our control but we'll try to keep you as up-to-date about what's happening as much as we can. We try to make sure you have 4 weeks' notice before anything happens. If we're going to make big changes, there'll be a 'consultation period' which lasts about 6 weeks. This means that you've got time to let us know how you feel.

It's easy to let us know what you think...

We want to hear what you and your representatives think about change and to make sure it's easy for you to let us know, all of our contact details can be found on all our posters and letters. You can contact us by email, letter or phone.

How will you find out about the final plans?

We'll be letting you know in as many ways as possible. There'll be posters put up in or around your local area, letting you know what's going on. We'll also write to local representatives and, the information will be on our website.

If you let us know what you think, we'll make sure you know about our final plans either by writing to you, or having the information easily available in the Post Office or on our website.

What can you do if you think we haven't followed the Code of Practice?

If you don't think we've followed the Code, then please write to us or email us via the contact details included in this letter and let us know why.
