Additional Items:

Police Report circulated prior to meeting. M Pollock spoke to this report and answered questions, particularly on school pedestrian areas where police are patrolling during the day. It was noted improved signage is required. It was proposed local Councillors should arrange with GCC Roads Dept to meet with WCC to discuss signage.

Headteacher of St Paul's Primary School J Kerr discussed vision for vacant space at Palladium Place and his vision for it to be a community space that all schools in area and groups can use. Some repairs are required, including improved lighting. WCC gave some advice including contacting Woodland Trust for saplings and asking Parent Council to apply for Area Partnership grant. J Kerr was thanked and left the meeting after confirming out of school care should begin at St Paul's in August.

- **3.2. Hustings** Hustings will take place at Whiteinch Centre on 21st April at 7pm. Leaflets will be distributed by CC members. All candidates except one confirmed attendance. Microphones to be purchased. Each candidate will be given short period of time to speak with audience able to ask questions.

- **3.4 City Fibre Programme trees –** Councillors contacted regarding ongoing City Fibre programme in Whiteinch, digging up trees and lack of public footpaths. GCC advised their permission was not required for this work and "All care and attention will be observed to avoid any damage regarding minor roots and other utility services within the area".
