#### **SECTION 1 - INTRODUCTION**

- 1. This Plan has been initiated by the Parish Council in order so that, in the event of an emergency occurring in the village of Netherhampton, there is a clear understanding of the roles and responsibilities of the Parish Emergency Response Team (PERT), the various support agencies, and a plan to enlist local people to help others in the community including a list of contacts should residents require help in the event of an emergency.
- 2. The plan is intended to provide a self-help response, during any emergency affecting the parish community when the normal emergency response by the Emergency Services and/or County Council is delayed because of the scope or nature of the emergency.

#### **SECTION 2 - AIM OF THIS PLAN**

3. To provide a self-help framework that will assist in the local response to an emergency when assistance from the Emergency Services and other responders is delayed.

#### **SECTION 3 - OBJECTIVES OF THIS PLAN**

- 4. The objectives of this plan are to:
  - a. To establish a local emergency management structure.
  - b. To give an overview of roles and responsibilities.
  - c. To detail cascade call-out arrangements.
  - d. Identify available community resources personnel, equipment and emergency accommodation.

### **SECTION 4 - WHAT IS AN EMERGENCY?**

- 5. The formal definition of an emergency is "An incident arising, with or without warning, threatening or causing death or serious disruption to significant numbers of people, property or the environment, in excess of that which can be dealt with by the public services operating under normal conditions and requiring the special mobilisation and organisation of those services and the deployment of local authority staff and resources".
- 6. Under the Civil Contingencies Act 2004 an emergency is defined as 'An event or situation which threatens serious damage to:
  - a. Human welfare
  - b. The environment
  - c. Security of the United Kingdom.'
- 7. Wiltshire County Council has an Emergency Management Team that works in partnership with the Emergency services and voluntary agencies in order to provide a coordinated response to a major incident. The Police have overall responsibility for control and co-ordination in an emergency situation. The county council have specific responsibilities, which include establishing emergency

centres, providing temporary accommodation for those made homeless and managing the longer-term recovery phase.

8. This local emergency plan has been drawn up under the auspices of the Parish Council, with help from representatives in the community who could be called upon for assistance. A key element is individual Councillors/community emergency wardens who would be the main contact for each limited geographical area, who would co-ordinate local needs, in communication with an Operations Room at the Parish Council Emergency Control Centre office.

#### **SECTION 5 - LEVELS OF EMERGENCY**

- 9. There are three recognised levels of emergency:
  - a. A major catastrophic event in a large city or town in the south west, requiring large capacity shelters and support. Such incidents would require very large premises (far larger than St Catherine's Church, for instance) to accommodate and manage large numbers of temporary "refugees". We need not concern ourselves too much with this category as the Parish Council would be approached as part of a measured, coordinated scheme initiated by a higher tier authority.
  - b. A major emergency at County level, or beyond, where the management of the event would be undertaken at County level. Whilst St Catherine's Church could well be a receiving station for dispersed persons, and selected local people involved in support, this need not be of immediate concern locally, as support services would be mobilised to aid.
  - c. A local emergency within the Parish of Netherhampton which, though inevitably involving the higher levels of Government for support (such as the supply of sandbags due to flooding), needs a high level of local involvement by local people as it is they who are most likely to know who is likely to be at risk and/or in need.

# This Plan concentrates entirely on this third category.

# **SECTION 6 - WHAT SORT OF EMERGENCY?**

- 10. For the purpose of this plan, Netherhampton Parish Council (NPC) recognises four levels of emergency:
  - a. Flooding.
  - b. Large scale evacuation due to a major event, e.g. major fire, pollution incident.
  - c. A pandemic health threat.
  - d. Prolonged power outage.
- 11. Whilst all would inevitably involve the emergency services and/or the major authorities, the knowledge of local people will be vital in mitigating the effects on the local community. Flooding is perhaps the most likely scenario, hence the inclusion of a **Flood Plan** as at Annex F to this document.

### SECTION 7 - WHO IS RESPONSIBLE, FOR WHAT, IN AN EMERGENCY?

- 12. This document lists the principal actions of each organisation. However, it must be noted that it may not always be possible for all actions to be carried out during all emergencies.
- 13. Responding organisations have limited resources so may not be able to provide assistance in all circumstances. Owners and occupiers need to be aware that they should make their own arrangements to protect their property from risk, especially flooding. Many factors may influence the level of response to specific emergencies. Priority is likely to be given to those that are vulnerable when assisting people, and to property which is occupied. The classification of roads may be used in prioritising the response to road flooding; protection of commercial property may depend on the risk of environmental pollution from stored chemicals etc.

#### **SECTION 8 - PARISH ROLES AND RESPONSIBILITIES**

# **ROLE OF THE PARISH EMERGENCY CO-ORDINATOR**

- 14. The Parish Emergency Co-Ordinator is the lead for the Parish and will take overall control of any Parish input to an emergency situation. The role of the Parish emergency co-ordinator is:
  - a. To advise and help local community preparations for the response to an emergency.
  - b. Assess local problems that may arise in the event of abnormal circumstances such as a major incident or a natural disaster occurring.
  - c. Identify vulnerable local residents such as the elderly who may require assistance.( this will be dealt with by local groups W.I, Meals on Wheels, WRVS, British Legion )
  - d. To determine the capabilities of the community to care for itself during an emergency in the absence of support from the emergency services and county/borough authorities.
  - e. To prepare and maintain the Community Emergency Resources Register.
- 15. Role of the Parish emergency co-ordinator *during* a major incident.
  - Assess the situation within the community.
  - b. If isolated, co-ordinate some immediate self-help recovery.
  - c. To organise such local resources as are available within the community.
  - d. To provide local knowledge to the emergency services or other organisations, as and when they are able to respond to the incident.

### RESPONSIBILITIES OF THE PARISH EMERGENCY CO-ORDINATOR

- 16. The Parish Emergency Co-ordinator is to:
  - a. To ensure that Councillors/ Community Emergency Wardens are aware of their role should an emergency occur.
  - b. To ensure that the local community is aware of the Parish Council's Emergency Plan and that residents are aware of Councillor's/ Community Emergency Warden's contact details.
  - c. To ensure that all those involved in the cascade call out system are aware of what action they have to take.
  - d. To maintain the Community Emergency Resource Register with the aid of the Councillors/Community Emergency Wardens.
  - e. To liaise with the Wiltshire Council's Safety and Emergency Planning Adviser to identify suitable training that may be available to emergency volunteers.

### **RESPONSIBILITIES OF COUNCILLORS / COMMUNITY EMERGENCY WARDENS**

- 17. Nominated Parish Councillors will also have a role to play in supporting the Emergency Coordinator. They are to:
  - a. To assist the Parish Emergency Co-ordinator in identifying other community volunteers.
  - b. To take part in exercises arranged to test the cascade call out system and working of the register. (desk top test the plan)
  - c. To assist the Parish Council in dealing with any emergency which may affect the community.
  - d. Review the plan/actions following an emergency and amend as appropriate

# **SECTION 9 - ROLES AND RESPONSIBILITIES OF OTHER AGENCIES**

18. The Emergency Services will normally provide most of the initial response. They will be supported by the local authorities, Environment Agency, utility (Gas, water and electricity) companies and voluntary organisations. The emergency services' main role will most frequently be to save life. <a href="If">If</a> <a href="Image: there is any risk to life at all contact 999.">Image: there is any risk to life at all contact 999.</a> The Fire and Rescue Service is responsible for rescuing survivors. The Ambulance service is responsible for treating casualties and taking them to hospital. The Police will help co-ordinate this work.

#### 19. Certain roles are:

#### a. **Police**:

- (1) Inform other emergency services about the incident.
- (2) Co-ordinate the emergency services and other organisations during the response phase.
- (3) Protect and preserve the scene.
- (4) Investigate the incident alongside other investigative organisations.
- (5) Collect and pass on information about casualties
- (6) Identify those involved.
- (7) Restore stability with the aim of restoring normality.

# b. Fire and Rescue Service:

- (1) Inform other emergency services about the incident.
- (2) Rescue.
- (3) Respond to all emergency incidents as required.
- (4) Assist the populace where a need is identified and the use of Fire Service personnel and equipment is relevant.
- (5) Tackle fires or chemicals which have been spilt and other dangerous situations.
- (6) Make sure all personnel involved in the rescue work are safe
- (7) Gather information and carry out hazard assessments.
- (8) Help ambulance service get live casualties away from the scene
- (9) Help Police recover bodies
- (10) Restore stability with the aim of restoring normality.

#### c. **Ambulance Service**:

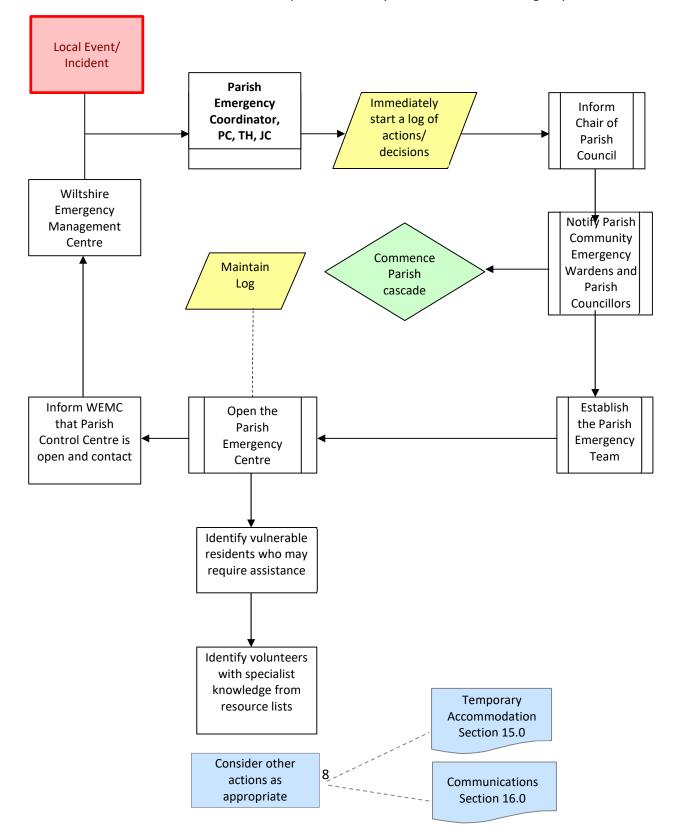
- (1) Inform other emergency services about the incident.
- (2) Provide a focal point for all medical resources.
- (3) Identify and contact the appropriate receiving hospitals.
- (4) Set up a casualty clearing station.
- (5) Prioritise casualties so that their injuries can be treated.
- (6) Prioritise which casualties must be evacuated using appropriate transport
- (7) Restore stability with the aim of restoring normality.

# d. Environment Agency:

- (1) Issue Flood Warnings
- (2) Receive and record details of flooding incidents
- (3) Monitor the situation and advise other organisations
- (4) Deal with emergency repairs and blockages on main rivers, adopted critical watercourses and own structures
- (5) Respond to pollution incidents
- (5) Advise on waste disposal issues

### **SECTION 10 - COMMUNICATIONS**

20. The flowchart below shows the contact points necessary in the event of an emergency.



#### **SECTION 11 - PARISH EMERGENCY CONTROL CENTRE**

21. A building should be identified that is capable of being used as a 24-hour parish emergency centre. It should preferably have a central location and be well known to local residents. Consideration should be given to communications e.g. telephone, fax, and computer links. The accommodation should include cooking, washing and toilet facilities.

- 4. LOSS OF UTILITIES When electricity, gas, water is lost, turn to Annexe K.

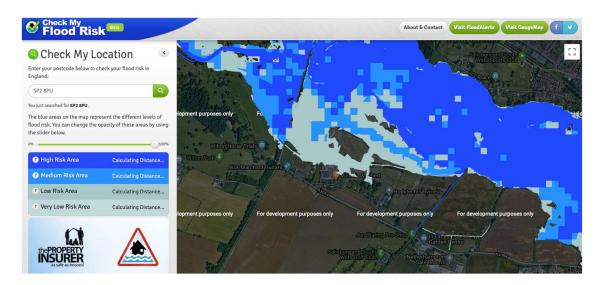

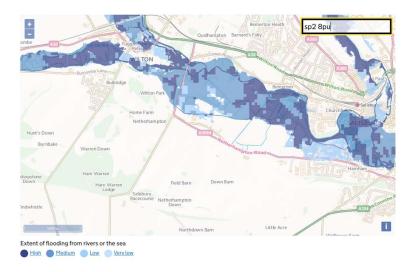

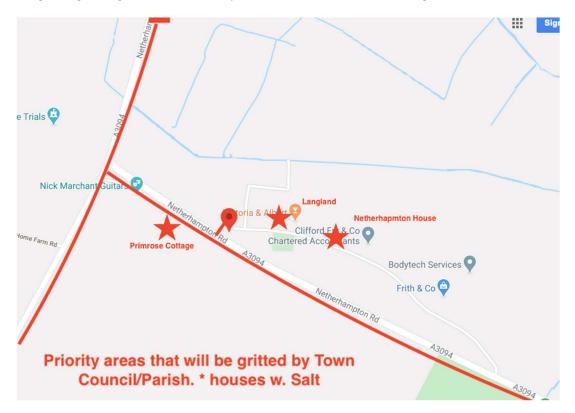

# **HEALTH PANDEMIC**

TRIGGER - PANDEMIC DECLARED BY WORLD HEALTH ORGANISATION

# 1. Form emergency committee

- include health care professionals if possible. Make this committee larger than others, since during a full pandemic up to half the committee could catch the flu.

- Consider cancelling public gatherings and meetings, as advised by the NHS
- Activate volunteers to help people living alone with:

Dropping off food

Dropping off prescriptions / anti-viral flu drugs

Looking after pets

Keeping in touch with infected people through email / phone.
