Caravan Hire is subject to the following terms & conditions

By hiring the caravan the hirer is deemed to have accepted and will abide by these terms and conditions.

Contract

The Contract for a short-term holiday rental shall be made between the Hirer and Mr & Mrs R.Cooke- (hereby known as the owners). The Contract shall be governed by UK Law. It will be entered into when the deposit is processed by the owners who will issue the confirmation letter. The Contract will be subject to all the following booking conditions.

Payment

A deposit is payable of £25 for each week booked or 50% of the total if the booking is for less than one week and if made more than 28 days before the commencement of the rental. For bookings made less than 28 days before the commencement of the rental, the total rental fee is payable on booking. All payments shall be made using an agreed method.

Balance of Hire Cost

The balance is payable at least 28 clear days before your holiday begins. A receipt will be sent to acknowledge your deposit, this will show the balance to send 28 days before your holiday. Non-payment of the balance of the rental on or before the due date shall be construed as a cancellation of the contract by the Client and the deposit will not be refunded.

Cancellation

Any cancellation made by the Client for whatever reason shall be initially made by phone and then in writing. If the booking is cancelled within 28 days of the arrival date, the entire deposit fee will be forfeited. If you have to cancel before the start of your holiday the first and most important thing is to let us know, by phone then by email / first class letter, as soon as possible. It is to your advantage to give us the earliest warning of a cancellation to enable us to try to re-let the accommodation. The deposit will only be returned if we are able to re-let the accommodation.

Once a booking has been made a legal contract exists.

Deposits, Cancellations and Transfers

Should we not receive the balance by the due date then we will attempt to contact the hirer using the contact details with which we have been supplied, but it remains the hirer's responsibility to ensure the balance is paid on time. If we have still not received the balance 5 days after the due date, then the booking will be deemed to have been cancelled, the deposit will be forfeited and we will be free to re-let the accommodation.

Period of Hire

Unless otherwise agreed, rentals commence at 2.0pm on the day of arrival and terminate at 10.0am on the day of departure, as set out in the booking form enclosed. If you do take over the accommodation before the allotted time we cannot be held responsible for the condition of the caravan.

Availability

The booking is made on the understanding that the property will be placed at your disposal on the date stated. Should this not be possible through circumstances not under the control of the owner (e.g. fire, theft or damage) we will attempt, although we cannot guarantee, to provide an alternative property in which case all monies paid shall be returned in full, but the hirer shall have no further claim against the owners.

Number of Persons in the Property

The number of persons occupying the property must not exceed the maximum number stipulated and disclosed on the booking form. We, the owners, reserve the right to refuse entry to the entire party if this condition is not observed. The hirer is responsible for all members of his party.

Children

Guests must accept responsibility for the conduct and safety of their children. We the owners advise the guardians of children to make themselves aware of any hazards in or around the accommodation at the start of the stay.

Care of the Property

The Hirer shall take reasonable and proper care of the property and its furniture, pictures, fittings and effects in or on the property and leave them in the same state of repair and in the same clean and tidy condition at the end of the rental period as at the beginning. The hirer will be responsible for all costs incurred due to damage caused by negligent acts. Any additional cleaning costs will be invoiced to the Hirer.

Minor breakages, cups, plates, glasses etc will not normally be charged for but do please let us know so that they can be replaced.

We accept no responsibility for misuse of any contents, appliances, fixtures & fittings. The Hirer is solely responsible in relation to the supervision of all members of your party whilst in occupation of the caravan.

In the event of loss of keys for the caravan during your stay, the person booking the stay will be liable for the full cost of replacement of all locks and keys by a qualified locksmith.

Smoking

In the interests of safety and for the comfort of all of our guests, smoking is not permitted in this caravan

Liability

We, the owners, its employees and agents do not accept third party liability in respect of breach of contract, negligence, misrepresentation or otherwise.

The owners shall not be liable for any injury to any person on holiday in, or visiting the holiday accommodation, or for any loss of, or damage to the property of any such person, howsoever any such injury, loss or damage may be caused.

Car Parking at the accommodation is at the owners risk.

Pets

Pets are allowed in the accommodation at the owners discretion and agreement and subject to a small charge. Hirers are responsible for their pets whilst in the accommodation and on the site. Dogs must be kept on a lead at all times on site and any fouling removed and disposed of. Any damage caused by pets will be chargeable and payable by the Hirer.

(Please note that the site has access on to a main road and is not secure against pets straying.)

Holiday Insurance

We do not provide holiday insurance. You will be responsible for arranging your own insurance in case of cancellation. Please note also that our general insurance does not cover your valuables or belongings.
