5. To Receive Crime Report for Rugeley – PC Joanne Manser – Neighbourhood Officer

PC Joanne Manser introduced herself to the Council Members as the new Neighbourhood Officer for Rugeley and Brereton Area. She explained that the area had not had a neighbourhood officer for some 12 months and she hoped that she could address issues that had arisen. It was explained that crime had increased in Rugeley however anti-social behaviour had decreased slightly. In her role PC Manser would be looking at the anti-social

behaviour especially within the young demographic. The Chair asked members that if they had particular questions they wished to ask PC Manser could they get in contact with the Clerk so she can forward on the questions so that PC Manser will be able to look into the matter before the meetings.

11. Budget 2017-2018

The Members discussed the budgets presented to them from both the Finance and Management committee and Councillor D. Gaye. Discussions took place on the proposed increases of 1.9% and 0.3%. With the 1.9% increase it would work out as a 93pence a year increase on Band D households. Councillor D. Gaye proposed his budget of 0.3% increase however there was no seconded. Councillor R. Alexander proposed the 1.9% increase budget which was a precept of £298208 (two hundred and ninety eight thousand, two hundred and eight pounds only). This proposal was seconded by Councillor I. Hodgson and it was
