- Mrs A. Cooney explained that in Item 11 Display Energy Certificate that this was a certificate relating to the building not individual appliances.
- Mr C. Green explained that currently there were many letters going back and forth regarding the Horsefair road works and the delays which is impacting local businesses. He also thanked Councillor G. Martin for his assistance with the Town Guide and that there was still a shortfall and any assistance in the matter would help already struggling traders. The Duck Race that took place on 28 June 2014 was a success and raised money for the Lions Club and would be distributed between various charities. The next Rugeley Trader event will be a Table Top sale that will be held first Saturday of the month for the next three months.
- Mr B. Dipple explained he was waiting for the Local Parking report to be issued by Eric Pickles and he would be hoping that at the next Full Council meeting Councillors we give their comments as the Council should be acting for the local people.
- Mr C. Green explained that the Rugeley Traders had organised for a Christmas Tree for Market Square which would be the 'Tree of Light'. The Rugeley Traders are also looking at having a 'living' Christmas Tree on the Eaton Lodge roundabout which Councillor G. Martin had said he would help fund.
- Ms K. McBey of Cannock Chase Council explained that Item 16 regarding the Designer Outlet Village was not a matter for Cannock Chase Council but the Developer and therefore it would be them the Council would need to be in contact with.
