The reserves look healthy at the moment, but with a recent rise in water charges outgoings are likely to exceed income.

There are also some hall maintenance expenses to come. Exterior decoration of facias etc. will cost £560 and estimates are being obtained to replace the side windows.

The trustees have not been able to raise money via hall events eg. the monthly lunch, due to covid restrictions.

The Council RESOLVED to agree to apply to the OCC fibre provision project.
