On the laybys. I have composed a letter to the Secretary of State and I am waiting on the leaders sign off for it to be sent. Should he refuse to help in spite of the need for better HGV facilities I have told the team to immediately demolish the buildings as I can't get agreement from the District to take on maintenance and the property department can't see a route to financially maintain them."
