HAZARD

- 1. Trips/falls in play area, recreation ground and cemetery
- 2. Entrapment when using play equipment
- 3. Risk of diseases from dog excrement
- 4. Effects of chemicals when applying weed killer
- 5. Risk of fire when using/storing flammable liquids such as diesel/petrol
- 6. Accidents with vehicles ride on mower and tractor/gang mower/strimmer
- 7. Injury from unsafe/insecure headstones in cemetery
- 8. Danger or injury resulting from fly tipping

WHO MIGHT BE HARMED

Hazards 1, 2, and 3 above - children using play equipment and persons visiting cemetery

Hazard 4 – councillors/contractors whilst applying the weed killer

Hazard 5 and 6 – the grounds man operating the mowers Hazard 7 – persons visiting the cemetery

Hazard 8 – General public

IS MORE NEEDED TO CONTROL THE RISK

Hazard 1 - Trips/falls in play area, recreation ground and cemetery

- a) Ensure play area free from rubbish and obstacles by regularly checking area and removing rubbish and any obstacles.
- b) Minimise injury from falls by ensuring that there are sufficient bark chippings around the play equipment.
- c) Regularly check play equipment to ensure that it is in full working order and has not been vandalised or showing signs of wear and tear.
- d) Any potholes in paths or uneven ground to be reported to Clerk and repaired.

Hazard 2 - Entrapment when using play equipment

- a) Ensure equipment checked regularly and in proper working order
- b) Report any problems to the Clerk
- c) Advertise that young children are to be supervised by an adult when using the equipment.

Hazard 3 - Risk of diseases from dog excrement

a) Notice displayed saying that no dogs allowed in the play area.

Hazard 4 - Effects of chemicals when applying weed killer

- a) Ensure that masks and goggles are provided for use when weed killer is being applied.
- b) Ensure chemicals are prepared and applied in accordance with the manufacturer's instructions.

Hazard 5 - Risk of fire when using/storing flammable liquids such as diesel/petrol

- a) Ensure the operators have been instructed on the use of the tractor and gang mower.
- b) Ensure that fueling is carried out safely.
- c) Ensure that petrol is stored in approved containers and kept in a secure area away from inflammable items.

Hazard 6 - Accidents with vehicles - ride on mower and tractor/gang mower / strimmer

- a) Only authorised operators to use vehicles and machinery.
- b) Ensure that all vehicles and machinery is regularly maintained and in correct working order.

Hazard 7 - Injury from unsafe/insecure headstones in Cemetery

- a) Any loose or unsafe headstones to be reported to the Clerk and owner identified and asked to make secure.
- b) Area around unsafe headstones to be taped off immediately to prevent public access.

Hazard 8 - Danger or injury resulting from fly tipping

- a) All fly tipping to be reported to South Oxfordshire District Council
- b) If the contents are considered high risk details to be given when reported to the Clerk and appropriate action taken to minimise risk.
- c) Regular checks to be carried out to identify fly tipping
