**158.** APOLOGIES FOR ABSENCE – received from Cllr D Waters

- **159. DECLARATIONS OF INTEREST** Cllr Leeding declared an interest in the Village Hall, OFOG, The Holford Trust, Gardening Club and as a resident of Mickle Way.
- **160. PUBLIC FORUM** Mickle Way and football the children play football in the square. SOHA have written a letter to a resident and a reminder to all residents' letter. The Police have previously sent a letter to a resident about Anti-Social Behaviour and how to report it. Resident's concerns were that it is dangerous for the children with footballs and children have been into gardens collecting the balls. There is concern over hitting a child and damage to vehicles. A SOHA letter dated 30th March 2023 has been sent to residents. Cllr Leeding had not received a letter but has had a ball in the garden. The turning circle is part of the public highway. Football can be played in the Rec, but children cannot be made to go there. There is a safety issue for the children, but the PC has no authority to do anything about it. Options are to write to SOHA on behalf of the residents and ask them to take the matter seriously as it is Anti-Social behaviour. Write to the police and ask them to visit the houses. As a PC we have no authority to do anything. The PC could put something in the newsletter to remind residents about ball games. The PC does not want to inflame the situation and will do what they can. Action: Cllr Bearder to write to SOHA. We could ask Highways about playing football and scooters on the turning circle but there are no laws stopping these activities on the Highway. The safety of the children is the main concern. Roads and Potholes – there is no money to repair Church Hill. Milton Crescent and Powell Close have been resurfaced. Action: AWB to put a cone in the pothole. The flooded road has had work done on it, but the soakaway has been invaded by tree roots. It was cleared two years ago but the whole area needs doing again, and Church Hill. The stream needs to be culverted. Corner House overhanging branches. Churchyard - overhanging branches from Shotover Estate. Action: PC to ask DW to have a look. The PC are not planning any events for the Coronation. The public forum closed at 20:05 and Cllr Bearder left the meeting.
