- **91. APOLOGIES FOR ABSENCE** W Blyth, D Waters, M Leeding
- **92. DECLARATIONS OF INTEREST** None.
- 93. PUBLIC FORUM Julia, representing the Baby and Toddler Group requested a grant of £1,000 as the rent for the hall has gone up. PC to ask the VH Committee to look more favourably as the £1,000 grant would be for rent. Five or six families, mainly from Forest Hill attend the group and it is socially valuable. Cllr Waite Brown to talk to the Village Hall Committee about funding part or some of the rent or waiving/reducing the rent. The PC should get a discount. Action: Cllr Hobbins to speak to the Village Hall Chair to co-support the Baby and Toddler Group. All agreed (item 107 no 4). The Baby and Toddler Group do not yet have a bank account and were asked to return the cheque previously issued if it has run out. Action: Julia

- 95. UPDATE ON PROGRESS FROM MINUTES OF LAST MEETING Chairman/Clerk to report on progress of outstanding items that do not require further decision.
  - a) Rectory Farm water request Cllr Waite Brown has communicated with Rectory Farm regarding the Village Hall being unable to supply water to them. Receive an update from Cllr Waite Brown. No further updates have been received and the matter is now closed.

  - a) 20 MPH speed limit in Forest Hill the Clerk has asked the question regarding cost and viability of instating a pinch point at entrance to village from Stanton St John, with priority given to vehicles leaving Forest Hill. The Clerk received a reply and the estimate was £30K for the works. Traffic surveys would cost £200-£300. To be considered at a later date.

  - **d)** Forest Hill planters discuss moving the planters, which currently cover the white gates put up to slow drivers entering the village. Consideration also needs to be made to possible insertion of pinch points (minute 75a). **Action**: Cllrs to have an onsite meeting to review the options.
