- **27. PUBLIC FORUM** Three members of the public observed the meeting.

- 29. UPDATE ON PROGRESS FROM MINUTES OF LAST MEETING Chairman/Clerk to report on progress of outstanding items that do not require further decision.
  - Telephone banking, Bank Statements and updating Bank Mandate the contact address for the bank statements has been updated.

Tracy is aware that works are due at some point for surfacing/patching but is not sure of any timescale yet. Tracy will look at this road when next in the area and raise any defects that meet OCC's intervention levels to be fixed.

Finances have been boosted by credit from Castle Water - £300 for inconvenience when the water supply was disrupted, plus £147 for over-estimations. A bill from SSE has not been received since February and could be for a large amount. The kitchen window is being replaced as it does not open properly, and the glass is blown. Also getting advice on repairs to the Hall floor. The Village Fete is on July 8<sup>th</sup> and this year will make more use of the Hall.

## 38. RECREATION GROUND:

- a) Purchase of new picnic benches three benches have been ordered and these will need to be built before use in the next 2-3 weeks. AWB and DW to put the benches together. The benches cost £150 each plus £50 delivery. The benches will be fixed to the ground.

  - OCC Community Tree Care Volunteers the PC will water the tree recently planted by OCC.
- web enquiry from MB are there any plans to install Power Points to charge electric vehicles? There are EV power points on lampposts in London. OCC and Highways would be responsible for EV chargers in Forest Hill. Action: Clerk to write to MB to say that the PC will look at other options for EV chargers. PC to monitor and think about it further.
