112. APOLOGIES FOR ABSENCE – Cllr A Waite Brown

- **113. DECLARATIONS OF INTEREST** Cllr Leeding declared an interest in the Village Hall, The Holford Trust, OFOG and the Gardening Club.
- 114. PUBLIC FORUM One member of the public attended the meeting to discuss the footpath and Rectory Farm vehicles. Access to the fields could be made by using the farmyard instead of the field track. A permanent water supply was not granted by the Village Hall Committee, and someone is now driving on the footpath. Legally the footpath must be kept open and can be used but there is an alternative access through the farmyard. Action: Clerk to send a polite request to find an alternative route through Manor Farm for access and to reduce the detrimental impact on the path. Potholes the cold weather has caused problems and potholes have appeared. Fix My Street is the only way to report potholes and footpath problems.

<u>Church Hill</u> – the speed bump and drainage issues. The culvert needs cleaning out and should be reported to Highways. It was last done 12 months ago. The vegetation has been cut back. Pedestrian access to the A40 public transport is difficult and residents are not able to access on foot (see item 117).

- **115. MINUTES OF LAST MEETING OF THE PARISH COUNCIL** held on Thursday 15th December 2023 Clerk to amend the minutes to show one member of the public had attended the meeting. Cllr Hobbins signed the minutes as a true and accurate record.
- **116. UPDATE ON PROGRESS FROM MINUTES OF LAST MEETING** Chairman/Clerk to report on progress of outstanding items that do not require further decision. Nothing to discuss.
- **117. OCC and SODC MATTERS** To receive reports.
- Toilet block on the A40 on the eastbound side has not been removed.
 There has been a problem disconnecting the services on the Forest Hill side and this has caused a delay.
- 2. <u>Cllr Bearder</u> reported that council tax would be going up by 4.99% to fund adult social care. £4.9 million to go to other schemes including the Comet Bus to expand the scheme. Transport initiatives there is no bus service from the villages to get into town. Need to tackle rural connectivity. Ditch clearance and

drains and cyclist and pedestrian access to the bus stop. Cllr Bearder has sent an email to Tracey and AWB has been in touch via Fix My Street. Botley Road traffic filters will be delayed due to patchy closures. The East West rail link is due to be completed in 2025 and the Zero Emission Zone will be accelerated out to the Plain etc. Drivers would need an electric car or be able to afford to pay the fees. Solving this issue is a problem. The proposed traffic filters at Marston Ferry Road may be scrapped due to delays with Botley Road. Cycle paths would require extra money. The whole idea of measures will lead to traffic evaporation and buses can travel easier, faster, and more efficiently. The Park and Ride used to be free but now must pay to park. It would be more attractive if there was free parking. The Thornhill car park is leased from Shotover Estate. 20,000 houses will be built in the Oxford Green Belt. 1450 houses and 120 assisted living units planned for LnBB and there will be changes to parking to insist on a zero-car policy, which is not for everyone. Edge of city developments are good for cycling, walking and buses. Expecting to see more zero car developments for edge of city sites. Christ Church have submitted their application. Northfields would have 1800 houses. Brasenose own the rest of the land and it would be car free so public transport is essential. For climate change to be net zero by 2050, one third would have to come from transport. Shepherds Pit Lane - proposal to close the road and make it a cul-de-sac. Cllr Bearder has talked to Stanton St John PC and Rectory Farm, and they are happy. It will make a nice cycle and walking route. Toilets on A40 – one has been taken down and the other block has been delayed, possibly due to bats. Cllr Bearder left the meeting at 20:10.

- **122.** BUS SERVICE and TRANSPORT To receive reports.
 - **a) Comet Service –** £750 grant agreed and cheque to be paid at the April meeting.
 - **b)** Report from Cllr Leeding the Comet Bus continues, and a small balance will be carried forward to the next financial year. Able to continue to fund for the next two years and will run as long as possible. All four parishes have agreed to contribute for 2022/23. Cllr Leeding has a supply of bus tickets for passengers to purchase.
- **123. VILLAGE and PARISH MATTERS** To receive any updates and matters for consideration.
 - a) Lampost on A40 Cllr Waite Brown has reported that the lamp by the bus shelter has been damaged the lamp is working but is hanging ongoing. A lamp by Vent Farm is on all day long and could be reported to Fix My Street.
 - **b) Old Cemetery hedge and wall** (since Dec 2021 min.2021/120) council sourcing quotes for repairing the wall ongoing. Cllr Leeding gave the Clerk a letter from Public Amenities at SODC dated 21.11.03 confirming that SODC will take over the maintenance responsibilities for the old cemetery on 22.12.03.
 - **c) Mickle Way noticeboard** proposed that the notice board be removed as part of spring clean-up day. Cllr Leeding would like to see the notice board repaired rather than removed as there are 80 houses

in Mickle Way. **Action**: Discuss again at the March meeting.

- **d)** Forest Hill planters discuss moving the planters, which currently cover the white gates put up to slow drivers entering the village agreed to talk to the people who put them up before moving them. **Action**: PC to look on Saturday 18th March and engage with members of the Gardening Club.
- e) Grass Cutting Quotes for 2023 from Cllr Hobbins: the contract with Green Scythe is for 3 years on a 3-year deal and they do a good job. Could reduce the work with a clear brief. **Action**: JH to ask for a quote for 1 and 3 years for the March meeting.
- f) To receive a resignation from the present Vice Chairman: ML is standing down as Vice Chairman and will not be standing again in the May 2023 elections. ML will continue to help and look after transport in the villages. ML has served 40 years as a Parish Councillor and has decided now to resign as the Vice Chairman. We all hope to see ML at the meetings in future, in the audience. ML to come to two more meetings and will continue to sign cheques until May.
- g) To consider election of a new Vice Chairman: If the Chair is not available then the Vice Chair would take the meeting. Informally, JH takes the meetings, or another Cllr can take the meeting if the Chair is not available. **Action**: Cllrs to talk to people in the village about the elections in May and vacant seats.
- h) Spring Clean-up with a skip on the Rec. Keep Britain Tidy campaign runs from 17th March to 2nd April 2023. PC would like to tie in with these dates. Proposed date Saturday 18th March 2023 at 2.00 pm meet at the Rec. Action? to book a 6-yard skip for Friday 17th March from? JH may have a contact and GB suggested Mead Skips. PC to advertise the date in the newsletter and on Facebook.
