157 BUS SERVICE and TRANSPORT:

- Report from the PTR the 108 bus is still running, and tickets have been sold. The demand is there but includes all sorts of travel. There is a 108-committee meeting next week. Hoping to get more information from the bus company. The bus can take 16 people with 7 standing in the aisle. The vehicle is not big enough and the step is not safe, and the gap is too big. Numbers are good and so are the drivers. ML uses the bus twice a week and keeps an eye on numbers for when the subsidy runs out. OCC are running the service. Two new passengers from Forest Hill on the bus who have not used a bus before. ML will take up any comments with the bus company.

- Temporary Road Closure at Forest Hill, Main Street. A temporary Notice is being made to implement the temporary closure and will operate from 18/03/2024. In the interests of public safety, it will be necessary for Oxfordshire County Council to close the road as detailed above to facilitate hedge trimming works. The anticipated completion date is 20/03/2024 (each day from 09:30hrs to 15:30hrs).
- Temporary Road Closure and "No Waiting" Restriction at Risinghurst & Sandhill and Forest Hill with Shotover, A40 (East Bound). A Temporary Traffic Regulation Order (TTRO) is being made to implement the temporary closure and "No Waiting" restriction and will operate from 02/04/2024 (at 20:00hrs). The estimated duration of the works is two nights until 04/04/2024 (at 06:00hrs) each night from 20:00hrs to 06:00hrs.
- Temporary Road Closure and "No Waiting" Restriction at Wheatley, Forest Hill & Risinghurst, A40 (WB) Wheatley to Thornhill P&R. A Temporary Traffic Regulation Order (TTRO) is being made to implement the temporary closure and "No Waiting" restriction and will operate from 04/04/2024 (at 20:00hrs). The estimated duration of the works is two nights until 06/04/2024 (at 06:00hrs) each night from 20:00hrs to 06:00hrs.
