480/22 BENCHES IN THE PARISH

Councillor Smith had prepared an update report regarding the purchase of the benches and picnic tables using the money received from 3PBL and this had been circulated to councillors in advance of the meeting. The following was agreed by council.

 Council agreed to add to their order a bench from the 3PBL in memory of Angela Bright. It was further agreed that the bench would be placed at Weston Rhyn Recreation Ground. 3PBL had been advised of the cost and would be sending the extra money to cover this cost.
 It was felt that the responsibility for each bench/picnic table would be passed to the relevant site owner. Cllr Smith, when discussing the placement for each piece, would make this clear to the relevant person. However, an official letter would need to be sent to avoid any queries at a future date. Action: the Clerk/Cllr Smith.

The wording for the plaque was to be finally confirmed with Tiz at 3PBL but as there was no provision for anything other than lettering, it was likely to be as stated in the report. Cllr Smith to follow up on that before order was made. *Action: Cllr Smith.*

It was proposed and seconded and resolved that the clerk would order the items. *Action: the Clerk/Cllr Smith.*

Clerk would also notify officially Chris Jones of Jones Brothers Weston Rhyn that they were the preferred contractor and that the items would be delivered to their yard in Station Road, Weston Rhyn. *Action: the Clerk.*Cllr Smith would contact each site owner to establish the position for each piece of furniture. *Action: Cllr Smith.*

 Cllr Smith would contact Nick Williams from Shropshire Council to make appropriate arrangements re. installation point at Chirk Bank Playground. Action: Cllr Smith.

481/22 **FUTURE OF CHIRK BANK METHODIST CHURCH**

- Electrical work needed major updating, causing the Chapel to close at Christmas for the near future.

- Speed Signs It was suggested that the Clerk contact Oswestry Town
 Council for prices and advice regarding their latest purchases of speed signs.

- It was **RESOLVED** to freeze the precept at £34,000 for the year 2023-2024. *Action: the Clerk.*
