441/22 PUBLIC OPEN SESSION

Members of the public were invited to question Councillors or raise any issues of concern for a period of 15 minutes.

A member of the public (Jane Trudgill) talked about the increase in volume and speed of traffic and the increase in agricultural traffic, through the Wern. A report had been sent to the Clerk and the Parish Council showing photographs of signage and road markings in need of maintenance.

Cllr Layland updated the Council on Community Speedwatch; the group had had their first meeting. However, the positions allowed in the village needed to include the Wern if possible.

Cllr Rob Macey informed the Council about flashing speed signs. Although it has been that some Parish Councils financed these signs, SALC and Shropshire Council were looking at the legality and the number of them around the county. This is a current and ongoing plan of work which will take a few months. Consideration would be given to put some budget aside for the future.

Cllr Paul Herbert arrived at 7.20pm.

Regarding additional signage and re-painting of roads, Cllr Macey was willing to meet up with the resident.

These items would also be included with the Highways Meeting involving a Shropshire Council Officer, Cllr A Hughes and Cllr P Barnett. The Clerk would send the resident's report to Shropshire Councillors Jones and Macey.

- Cllr Wallace had attended a Police Charter Zoom meeting and had been disappointed to find only 18 Parish Councils out of 150 present.

SHROPSHIRE COUNCILLORS

Cllr Mark Jones – updated the Council regarding integrated care systems and said that the Terms of Reference had been agreed.

Cllr Robert Macey – Shropshire was dealing with £5million as an overspend. The council had found savings of £30million for this year before inflation. An officer had taken control of the Highways' issue at the Wern Turn. Regarding Arriva Buses, the Clerk had been given contact details for James Willocks at Shropshire Council, who was going to help to get the council's letter to the people at Arriva.

The focus, across Shropshire, with many groups is the Cost-of-Living Crisis. Less people are volunteering in the county, but the most vulnerable are still being prioritised.

Cllr Herbert asked if there was going to be any money for cycle highways.

 The bike shelter was almost complete and was being used. There would be a public meeting in January.

453/22 REPORT FROM WESTON RHYN TRUST

The article on the Facebook page had received very positive comments.

The Trustees were congratulated for their work.

454/22 REPORT FROM WESTON RHYN VILLAGE INSTITUTE

No report had been received.

There was now no longer a treasurer or secretary on the Institute Committee, which should be made up of a mix of representatives of community group hirers.

The lack of heating was causing problems and was a complicated system. The Clerk was asked to invite Carl Rowley to a meeting to share the Institute problems with the Council.

Shropshire Cllr Mark Jones left at 8.11pm.

There were concerns around the use of the Institute as a meeting venue over the winter, if heating could not be guaranteed. *Action* – *the Clerk*

455/22 **WARM ROOM' AT CHIRK BANK METHODIST CHAPEL**

- As electrical work was soon to be needed here, it was looking unlikely that the schoolroom could be used this winter as a 'warm room'. Costs for the work were being sought.
- Chirk Bank Community Group would need to put in the application to the Parish Council if it wanted to go ahead. The next meeting was due to take place on November 21st.
- Since the last meeting, Coffee and Co. at St. John's have also made plans to run a 'warm room'.
- It was RESOLVED to wait for feedback on the electrical work and Coffee and Co. before making any more decisions.

456/22 **GRANT APPLICATION FROM 'COFFEE & CO'**.

- The council looked at the Grant Application from St John's Church, asking for £425. St John's also holds a Post Office on a Thursday, which is an obvious attraction.
- A proposal was made to allocate £425 to Coffee & Co. with the proviso that the group would request donations from the Lichfield Diocese in addition.
- An amendment was made to allocate the £425 to Coffee & Co. with no proviso.
- It was therefore **RESOLVED** to allocate £425 to Coffee & Co. to help to run a 'warm room'.

457/22 FINGER POST FOR INFORMATION NEAR CHIRK BANK BRIDGE

- Cllr S Barnett had researched the cost of finger posts. It was felt that a post
 near the bridge would be safer, as people meet in the space by the canal
 asking directions and it was not clear where the pavement ends and the road
 begins. There was a good example of a finger post in Chirk as well as a new
 one on the towpath near the Lion Quays.
- Chirk Bank Community Group would be willing to pay something towards it.
- The Clerk was requested to speak to C&RT first. It was also decided to ask Men's Sheds. The money to pay for this could come out of the 3PBL.
