1. Public Participation

5. Reports

5-1. Police

Note Present: Dave Hughes, PCSO.

Katie LeClaire, Police Officer.

Regarding reporting of statistics; the reporting systems had been experiencing technical faults but PCSOs would send August and September's reports as soon as possible.

Cllr P Barnett read out comments, which Cllr P Manley had passed on, from a resident, about traffic at the mini roundabout in the village, not abiding by the Highway Code.

The Community Speedwatch Group had had some success, at last, with police vetting and the group would soon be ready to start.

5-2. Shropshire Councillors



Note Cllr Mark Jones would send some information about a Healthy Weight campaign for information. STAR Housing was looking for a new Chief Executive.

Planning Enforcement had a new officer in place.

Cllr Rob Macey had seen the details of works on Station Road and what was going to be happening there. Rob would ask Highways which roads were on their list to work on. It was noted that work from the school to Chirk Bank was very poor.

Covid jabs were rolling out in the same way as before.

Regarding Energy bills, Marches Energy and other groups were doing home MOTs to check your home and offer solutions. There was some 'Cost of Living help' on Shropshire Council's website.

Regarding remote working, there would be hubs where people can go to work.

Community Tree scheme was open again, with 21,000 trees this year. There was a native hedgerow mix available which was new this year. These had to be in view of a public right of way or road.

There was a £15,000 fund for community groups from Veolia for community projects.

Purple bins had started in Gobowen and Oswestry. Rob had tried to check for delivery schedules.

Deliveries were going well but some were going missing, as some neighbours were not signing up and then taking one for themselves.

5-3. Chairman

Note The Chairman gave a report on the HR Meeting that had taken place in August.

Note The Clerk was leaving her job as Clerk to Ruabon Community Council and starting work soon as Clerk to Mold Town Council. This would be monitored over the coming months by both councils, as both councils were aware of the situation. No problems were anticipated at this time.

There is a problem with software issues on the defib at the Institute. This is being collected on the 13th of September and would be away for 2 days. Cllr Hughes would put a note into the cabinet to direct the public to others.

Cllr P Barnett mentioned that there was a defib at the Quinta. Cllr Hughes would check whether this one is publicly available 24/7.

Social Media. There was a reminder to Councillors to re-read the Parish Council's Social Media Policy. Councillors should refrain from using the title of councillor on social media posts, unless this had been previously agreed by the council.

6. Planning

6-1. Update on CIL funding

Note Cllr P Barnett informed the council that he had done some research, as a result of a course he attended in March. From 2012-2021, the Parish Council had received £62,000 from ClL funding. The Parish Council Accounts state that the 'Neighbourhood Fund' contains £20,000. This is another name for ClL. However, the rules as to how this money can be spent, seem vague, or seem to change. Four years ago, the Parish Council had been told that the money could not be used to fund LED streetlight replacements, but 2 other councils were allowed to do this. As a result of this, this council put the precept up that year. It rose by £6,000 to pay for the LED conversion and this has stayed at this level. It was suggested to speak to SALC for the latest rules and to visit the Government website. Cllr Mark Jones left the meeting at 7.56pm.
