### **Response to 'One Somerset' and The Future of Local Government in Somerset**

A joint statement from The Leaders of Mendip District Council, Sedgemoor District Council, Somerset West and Taunton Council and South Somerset District Council in Response to 'One Somerset' and The Future of Local Government in Somerset, has been issued.

*"We want to make it clear that the District Councils of Somerset do not support 'One Somerset' and the proposals for a single council for Somerset.*

*"The detailed work which the five councils of Somerset commissioned together clearly concluded that a single council was the wrong solution for the people and communities of Somerset."*

### **Mendip District Council changes**

MDC Cllr Bente Height has joined the Conservative Party. Cllr Height (previously Independent) was re-elected in 2019 as District Councillor for Shepton East and is deputy chair of the Council. She is also a Town Councillor.

The move does not alter the balance of power at MDC – the LibDems remain the largest group with 23 councillors out of 47. The Conservatives are now the official opposition the 11 councillors.

### **Mendip push ahead with social housing plan after 20-year gap**

Mendip's ambitious plans to provide much-needed social housing right across the district is a step closer. The scheme promises to create jobs, boost skills and the local economy, while leaving a lasting legacy of social homes offering fair rents for residents. The Council has looked at Mendip-owned sites and identified numerous potential plots. Five of these could be shovel-ready within months.

Cllr Liz Leyshon, Portfolio Holder for Corporate Projects, said: *"It's time for us to step up and commit to providing residents with homes at decent, manageable rents - homes which are in extremely short supply. ### **Mendip Council transfers Boyle Cross**

You may have heard that the much-loved local landmark in the centre of Frome is to be transferred, in its entirety, to Frome Town Council who will now look after the historic open space and fountain on High Street. Mendip also agreed to provide a one-off payment of £9K to support the annual requirements at the site for the next 12 months. It's not the first time Mendip has placed much-loved amenities into community hands. In January 2020, Bishops Barn and recreation ground in Wells, were offered back to residents. And Street Parish Council took back Merriman Park from the District Council some years ago.

Leader of Mendip District Council, Cllr Ros Wyke, said: *"We are delighted to be able to return Boyle Cross to the residents of Frome. We know it is valued by those who live there and that people take great pride in it. We look forward to seeing this historic landmark flourish."*

### **Reduced rate of VAT of 5% for firms**

Mendip businesses can take advantage of this rate cut. This applies to hospitality, hotel and holiday accommodation and admissions to certain attractions. This temporary rate will apply from 16th July 2020 to 12th January 2021.

### **Kick-starting tourism**

A £10m **Kickstart Tourism Grant** has been announced. The scheme isn't up and running yet, but will offer grants of between £1k and £5k to tourism businesses for either professional fees or services and/or for IT/online support this summer. It will be administered by the Growth Hubs - not Mendip – so local Mendip businesses should contact the **Heart of the South West Growth Hub** via the email address [info@heartofswgrowthhub.co.uk](mailto:info@heartofswgrowthhub.co.uk) – preferably with a subject line like 'Tourism Grant enquiry' so they can be added to the list to be contacted when the scheme opens properly.

## **COVID-19 national updates**

### **Plan for jobs**

The Chancellor of the Exchequer, Rishi Sunak, presented his 'Plan for Jobs' to Parliament to outline how the Government will boost job creation in the UK.

Among the measures are details of how the Government will introduce a one-off payment of £1,000 to UK employers for every furloughed employee who remains continuously employed through to the end of January next year.

### **Masks are mandatory in shops**

The wearing a face covering in shops and supermarkets in England is to become compulsory from 24<sup>th</sup> July. Enforcement will be carried out by police and anyone failing to comply will be subject to a fine of up to £100, [or £50 if paid within 14 days].

### **Disposing of face coverings and PPE**

With all that extra PPE about, we must ensure our streets remain litter-free and safe. Below is the Government's guidance on how to dispose of personal or business waste, including face coverings and PPE, during the coronavirus pandemic.

If the public needs to throw away used face coverings or PPE, such as gloves, they should:

- dispose of them in the 'black bag' waste bin at home or at work, or a litter bin if outside
- not put them in a recycling bin as they cannot be recycled through conventional recycling facilities
- take them home if there is no litter bin – do not drop them as litter

### **Meal deal this August**

Restaurants, bars, cafes and other establishments have been signing up to take part in the UK-wide Eat Out to Help Out scheme. The scheme will offer a 50% reduction, up to a maximum of £10 per person, to all diners who eat and/or drink-in throughout August.

Businesses simply reclaim the discounted amount through an online service, supported by HM Revenue and Customs (HMRC). Claims can be made on a weekly basis and will be paid into bank accounts within five working days.

The Eat Out to Help Out scheme will operate as follows:

- all day, every Monday, Tuesday and Wednesday from 3 to 31 August 2020
- to offer a 50% discount, up to a maximum of £10 per person, to diners for food or non-alcoholic drinks to eat or drink in
- alcohol and service charges excluded and not applicable to takeaway food/drink
- claim the money back from the Government
