# Barriers on Footpath between Hall Road and the School

On the 17<sup>th</sup> July we received an email from Keith Sampson at Suffolk highways- I have received a response from the Section 278 team in the attached e-mail. Basically, they will be reinstating the barriers as per the rough picture in the e-mail where the black arrows are. They need to draw this up properly and discuss this with the developer. In the meantime they will install temporary barriers until the changes are made. It was also raised about the new badger houses at Lakeside Rise that there is no footpath from Stephen George way to the footpath opposite the school as people are having to walk on the road it was agreed to contact Justin Coote to clarify if this will be done.

#### Roundabout in Playpark

We are still waiting for the quote from B.F.S a Councillor said they would chase this up.

#### **Beacon On Millennium Green**

We had two quotes for the replacement Oak Pole, it was agreed to go with Traditional Beams at a cost of £1585+ VAT

#### **Notice Board in the Street**

The clerk went to see the team at the Man Shed in Stradbroke Road who kindly sent someone to come out and take a look at the Notice Board to see if it could be refurbished they said this can be done but we will need to get the notice board delivered to him it was agreed to get this arranged.

#### 5. Clerks Report:

The clerk has asked if the signatories would be prepared to be set up with online banking at the moment it is only myself and Keith that can make BACS payments and we need dual authorisation for each payment this was agreed at the meeting the clerk will send the details to them.

# 6. Public. Participation (15 mins)

A Parishioner raised their concerns about the speeding in Hall Lane and asked how we can stop this? The

Councillors said that we are in the process of setting up our SID Board in Queensway and Market Lane, but we have to comply with Highways legislation on the siting of the boards. It was asked if the Parishioner could contact PC Michelle Dean to report this direct the clerk will give you her email address,

## 7. Other Parish Business (Parish Councillors).

It was asked if we could find out from NGF Play re the Zipwire as to how many years recommendation for inspection is required for the Zipwire.

It was asked about the trees in the Millennium Green 3-4 months ago it was agreed for this to be looked at but nothing has been done as yet? And could we follow this up.

It was raised about the Junction at Flixton Road and Lound Road that the Grass verges need to be cut back again, a councillor is kindly cutting this back as it is only done twice a year by the council.

It was asked how the Teddy Bear Parachute Jump went? Barbara reported that 200 bears had jumped on the Saturday at a cost of £1 each but the actual amount raised would be more than this due to the sale of refreshments and other stalls across both days.

It was asked if the Minutes Books that need to be checked through to check for the Assets that the parish owns could be read at home, this was agreed at the meeting.

It was asked if anything can be done about the footpath between Hall Road and the School as there are so many weeds coming through it was agreed to take some pictures and report it on the highways reporting tool.

It was raised about the hedges in Lound Road as they are over hanging the paths. Could these be cut back to the boundary line? it was asked which houses they are and the clerk will send them a letter.

It was raised again about the fence in Lound Road as this case goes back to 2022. Cllr P Ashdown said he is still chasing this up with the planning officers.

It was reported on the reporting tool about two missing parking restriction signs at the school and was told they will be replaced but will take 14 weeks? Cllr P Ashdown said to contact Cllr K Robinson.

It was raised about the new Website that there are a few things that need to be amended and couple of changes needed before it goes live.

It was asked about the Dogs on Leads signs in the Millennium Green and that we still have not heard anything from the person who was dealing with this, it was asked to contact them again to find out where we are with this matter.
