# **MINUTES**

# Blundeston & Flixton Parish Council Meeting Held on Monday 17th Octobr 2022 at Blundeston Village Hall at 7.30pm

- 3. **Approval of Minutes**: Minutes of the previous meeting held on Monday 15<sup>th</sup> August 2022 were approved, (No Meeting was held in September)
- 4. **Declaration of interests** Keith Blowers declared an Interest in the Application\_DC/22/3307/FUL Church Road
- 5. Clerk's Report- Nothing to Report

# 6. 15 Minutes for Parishioners input -

Mr Ken Ward let everyone know that Blundeston Anglian in Bloom received the silver award and that next year they are going to do the Charles Dickens theme.

Another Parishioner mentioned about the Bike Show at the Plough Inn that was held in the village raised £650.00 in Donations and that this will be shared with local Blood Bikes and the East Anglian Air Ambulance.

It was also mentioned about the Hedge at the back of Barkis Meadow that the hedges are getting wider, and the footpath is disappearing underneath the vegetation. It was agreed that this could not be cut back until after September due to nesting birds, but this still has not been cut back. Anya will follow this up.

The footpath between Market Lane and the Street also needs repairing as this is a Public Right of Way and belongs to the County Council, Anya will contact Cllr Edward Back.

# 7. Other Parish Business (Parish Councillors)

It was raised that back in June cars were blocking the driveways in the village (The Street) and that Ambulances and fire services cannot get through and it was asked if we could have some white lines painted on the road. Anya will contact Cllr Edward Back who was dealing with this issue.

A councillor has been asked as to when the letter box will be replaced at the back of the Pre-School at Lakeside Rise as this was knocked down when they were cutting the grass Anya will contact Norse.

Keith Blowers thanked the Thursday night gang for a tremendous amount of hard work that they have done throughout the year.

A Councillor also wanted to thank Cllr Edward Back for repairs to Orchard Lane-Barkis Meadow footpath.

It was also asked if there is any progress in the Millennium Green footpath, it was agreed that just tarmacing between the grass would not be appropriate it needs more work to be done other than just tarmacing over the path . After a long discussion it was agreed to add this to the agenda for next months meeting to discuss further.

# **9. District Councillors Report**: (Cllr Paul Ashdown).

Paul also spoke about the project Ease the Squeeze and asked everyone to listen to people who might be struglling as they have funding for this project. Also the Holly Garden centre in Blundeston are going to open on a Monday in the café if people want to go and a have a bowl of soup, keep warm and have chat.

### 10. Sub committee to discuss Planning Applications

Due to the Planning Applications decisions needing to be returned within 21 days sometimes they fall outside of the meetings, it was agreed that we need 5 Parish Council members to Aprove or Refuse the Applications it was agreed that if Anya does not here back with a refusal that you are happy with the Planning Application if not a Sub Committee meeting will need to take place.

# 11. Blundeston Pre-School Portacabin

It had been asked if the parish Council would agree to screening or fencing around the portacabin as trees and shrubs would take a considerable to grow.

Pre-School in Lakeside Rise had planning permission back in 2019, it was agreed that this needs to go back to the Planning Department to make this decision.

# 12. Clerks Salary

It was agreed that the clerk's salary would now reflect £190.00 a month as from October 2022

# 13. Lakeside Rise Notice Board

It was agreed to add this to the agenda for the next meeting to discuss further.

### 14. Play Park

Since the last meeting 2 months ago the councillor's have been busy getting quotes for replacing equipment in the Play Park, we now have 3 quotes and these amount to the cost of around £60.000-£70.000 the parish has agreed to try and apply for funding from the Community Fund and the National Lottery Awards to help towards the costs.
