5] CORRESPONDENCE

NALC are urging parish councillors to consider supporting on an on-line petition to the Government to give powers to parish councils to appeal a Borough council decision. Currently they cannot do this. There could be a heavy financial impact if a parish council were to appear at an appeal, with legal representation required. The clerk was to circulate again to all members to allow them to make their own comment direct if they wished. The council itself is not asked to make a comment.

The council discussed the availability of the Queen's 90<sup>th</sup> birthday medal and agreed to order 70 of them at £1 99each, to be given to all children in the parish aged 16 and under and to anyone aged 90 and over. The council could also attempt to find if there was anyone in the past with a birthday on the same day as the Queen, on April 21.

6] PLANNING MATTERS

- Rushcliffe Borough Council planning applications

16/00022/ful. Stuart Bridge, Hill Farm House, Melton Road, Construction of new single storey commercial work unit within a completed courtyard development. Do no object.

18/00193/OUT Mr Mrs Eric Elliott, land east of Laurel Farm, Browns Lane. Outline application for the erection of a dwelling and garage. Some matters reserved. Object. The council object on the grounds the proposal is for new built within the Green Belt. The council are concerned that the unsightly barn is to remain and would wish to point out there may be an asbestos element there. Commenting on 'Some matters reserved' the parish would wish to say the rest of the site could still be used inappropriately, as in the year 2014 when there were scores of objections from residents on the noise, heavy goods traffic, dust and mess caused on the highway. The Borough were then seemingly unable to rectify the tremendous aggravation that was caused and this would be repeated again in the future while any purchaser would be unaware of the potential problem.
