2017-05-01	<p><b>Persons Present / Apologies for Absence:</b> S. McNair-Scott, S. Linnington, W. Drayson, D &amp; G Sewell, P. Thorne, N. Brookham, C. Langley, D. Ruscombe-King, N &amp; J Johnson. Cornwall Councillor B. Jordan also attended. Apologies: C. Key, D &amp; C Archer. In attendance: S. Theobald, Clerk.</p> <p>In the absence of the Chairman, C. Key, S. McNair-Scott took the Chair.</p>
2017-05-02	<p>It was RESOLVED that the Minutes of the meeting held on 16<sup>th</sup> March 2017, having been previously circulated and taken as read, were APPROVED and signed.</p>
2017-05-03	<p><b>Matters Arising:</b> It was NOTED that the pothole by the ford had not yet been repaired. Contact to be made with Cornwall Council, Highways, to request an urgent repair.</p>
2017-05-04	<p><b>Annual Governance Statement:</b> The Annual Governance Statement was scrutinised by the Chairman and APPROVED by those present. The Chairman signed the statement.</p>
2017-05-05	<p><b>Annual Statement of Accounts:</b> The Annual Statement of Accounts was examined by the Chairman and was APPROVED by those present. The Chairman signed the Annual Accounts Statement.</p>
2017-05-06	<p><b>Finance Report:</b> It was RESOLVED to ADOPT the bank reconciliation to 11<sup>th</sup> May 2017, which showed a balance of £2032.10. Reconciliation agreed and duly signed by the Chairman. There were no accounts outstanding for payment.</p>
2017-05-07	<p><b>Election of Chairman:</b> It was unanimously agreed that Chris Key be elected as Chairman for another term (12 months).</p>
2017-05-08	<p><b>Parish Website:</b> S. Mc Nair-Scott reported good feedback to the website with some 500 'hits' since its inception. He requested permission to display information about Church services and local events and activities. This was AGREED. The annual cost to Lesnewth Parish Meeting of maintaining the website was expected to be in the region of £55. This was AGREED.</p>
