2019. 12..47	<p>Persons Present / Apologies for Absence: S. McNair-Scott, C. Langley, C. Hayne, W. Drayson, D. Ruscombe-King, D & G Sewell, Cornwall Councillor B. Jordan also attended.</p> <p>Apologies: C. Key, N. Johnson.</p> <p>In attendance: S. Theobald, Clerk.</p>	
2019 12.48	<p>Report from CC B. Jordan: Cllr. Jordan informed the meeting that a 50mph speed limit was soon to be implemented through Otterham Station. He questioned the wisdom of Cornwall Council's plan to spend £3 million pounds developing Pydar Street in Truro and he felt it was a matter of concern that £20 million was owed to CC from unpaid Council Tax.</p> <p>It was noted that in a report from Citizens Advice Bureau debt had increased in the 50-69 age group. It was to be hoped that an integrated transport plan would soon be 'rolled out' in the South West at a cost of some £17 million pounds.</p> <p>Cllr. Jordan agreed to look into the status and tendering procedures of CORSA. It was understood that when a new waste collection contract was awarded black bag and recycling collection would be fortnightly and a food waste collection weekly. Cllr Jordan was thanked for his attendance.</p>	
2019 12.49	<p>Minutes: 17th May 2019: It was RESOLVED that the Minutes of the meeting held on 17th May 2019, having been previously circulated and taken as read, be APPROVED and signed, proposed C. Langley, seconded S. McNair-Scott. Agreed unanimously.</p>	
2019 12.50	<p>Matters Arising: No matters arising from these minutes.</p>	
2019 12.51	<p>PA19/02365/PREAPP: Land NW of Beechwood, Lesnewth. Pre-application advice for construction of live/work development, dwelling with artist studio.</p> <p>PA19/02761/PREAPP: Treworld Farmhouse, Lesnewth. Pre-application advice for construction of single storey, timber frame, timber clad dwelling. These pre-applications were noted.</p>	
2019 12.52	<p>To RESOLVE to ADOPT the Finance Report to 19th December 2019.</p> <p>Adoption of the finance report so presented was proposed by S. McNair-Scott, seconded by C. Hayne and agreed unanimously. It showed a balance of £2341.29. It was agreed that £350 be given to Lesnewth PCC to help with the upkeep of the cemetery and that the Clerk should be awarded £250 for her service to this Parish Meeting.</p>	
2019 12.53	<p>Budget and Precept Request: Having studied the figures for the past year it was proposed by C. Langley and seconded by D. Ruscombe-King that the precept requested from CC should remain at £720, agreed unanimously. Clerk to inform CC.</p>	<p>Clerk. Done 20.12.19.</p>

2019 12.54	Parish Website: S. Mc Nair-Scott reported good feedback to the website. The addition of an aerial photograph of the Parish was noted. All required documents had been uploaded.	
2019 12.55	Matters of public interest / Date of next meeting. The Clerk passed on the good wishes from Mark Versallion to all parishioners of Lesnewth for a Happy Christmas. He hopes to attend the next meeting. It was agreed the Clerk should investigate the possibility of joining the Local Maintenance Partnership in 2020 for footpaths, stiles and gateway cutting. It was thought to be necessary to replace the Parish Noticeboard in 2020. S. McNair-Scott agreed to look into the cost. It was agreed to hold the next meeting of this council in March 2020.
