| 2020<br>12/67 | <b>Planning Applications:</b><br>PA20/10117. Proposal: Change of use from holiday to residential and proposed porch. Location: Old Posting House, Treworld. Minster. Boscastle. Serious concerns from numerous residents had been expressed. It was felt the meeting could not support this application as the amenities and eco system around Treworld were very fragile. Bore Holes, fed by a natural spring, being the only water supply. Grey water and solid matter dealt with via septic tanks.<br>The meeting felt that no further development should take place on this site without first obtaining approval of the design from the Environment Agency to insure that ground water would not be contaminated and all waste water be disposed of without compromising the systems of other properties already in place. The meeting therefore Objects to this application. |        |
