This monthly report is intended to provide the local community with information on local policing issues and local police activity. Following consultation with the local community, the local priorities for the Grangemouth ward area are:

- Anti-Social Behaviour, Violence & Disorder

Ward Priorities

### **ASB, VIOLENCE & DISORDER**

During the reporting period there have been 18 crimefiles raised in relation to crimes of disorder. Of these, 10 crimefiles have been detected and 8 remain undetected with enquiries ongoing to trace the offenders.

- 13 of these crimes of disorder were in public places.
- 5 of these crimes of disorder were in private dwellings or were domestic in nature.
- 0 of these was youth related.

During the reporting period there have been 16 crimefiles raised in relation to crimes of assault. Of these, 9 crimefiles have been detected and 7 remain undetected with enquiries ongoing to trace the offenders.

- 4 of these was an assault in public place.
- 7 of these were assaults in private dwellings or were domestic in nature.
- 5 of these was youth related.

During the reporting period there have been 16 crimefiles raised in relation to crimes of vandalism. Of these, 6 crimefiles have been detected and 10 remain undetected with enquiries ongoing to trace the offenders.

- 11 of these were vandalisms to property.
- 5 of these were vandalisms to motor vehicles.

### DRUG DEALING & DRUG MISUSE

During the reporting period there have been 5 crimefiles raised in relation to drug related offences. These include offences for possession of controlled drugs, being concerned in the supply of controlled drugs and incidents where Recorded Police Warnings were issued.

During the reporting period there were 0 drugs search warrants executed in the Grangemouth ward area.

Drug dealing and drug misuse continue to be a problem in the local community. Any information in relation to suspected drug offences can be relayed directly to Police Scotland in strictest confidence by phoning 101 or anonymously by phoning Crimestoppers on 0800 555 111.

#### **ROAD SAFETY**

During the reporting period the following road traffic offences have been detected in the Grangemouth ward area:

- 11 Speeding offences
- 2 Mobile phone offence
- 0 No seatbelt offences
- 10 Miscellaneous (such as no mot)
- 4 No insurance
- 4 Drink driving
- 0 Driving whilst disqualified

In response to concerns raised by the local community in relation to speeding, ward officers have been utilising the Handheld Radar Device within the Grangemouth Ward area during the reporting period.

#### **DISHONESTY CRIMES**

During the reporting period there have been 23 crimefiles raised in relation to crimes of dishonesty. Of these, 7 crimefiles have been detected and 16 remain undetected with enquiries ongoing to trace the offenders.

- 1 of these was theft or attempted theft by housebreaking.
- 2 of these were thefts of motor vehicles.
- 3 of these were thefts from motor vehicles.
- 16 of these were minor thefts or thefts by shoplifting.
- 1 of these was related to fraud.

### OTHER LOCAL ISSUES AND EVENTS

The Bowhouse and Charlotte Dundas areas continue to be priority areas with extra police patrols deployed to prevent ASB, Disorder and Violence. In this regard, patrols of these areas by the local ward officers have been supported by officers on Local Days of Action duties and members of the Operational Support Division. The CAVRU (Community Alcohol and Violence reduction unit) have also been deployed to the area to complete patrols and liaise with local licensed premises.

Local ward officers are also paying close attention to the play park located within Inchyra Place, Grangemouth, due to the recent vandalisms that have occurred here.
