Minutes of Meeting held on 11th May 2023

Those present:

Councillors Howard Thomas, Peter Dinsdale, and David Suttill and the Clerk, Marina Briggs, attended the meeting along with Jenny Walker from the Water Committee, Andy Morson and three parishioners.

1. To receive Nominations and elect the Parish Council Chairman for 2023/24 and signature of Declaration of Acceptance of Office

Cllr Howard Thomas was nominated by Cllr Dinsdale and seconded by Cllr Suttill and all voted in favour.

RESOLVED: Cllr Thomas was elected as Chairman for the year 2023/24 and duly signed the Declaration of Acceptance of Office.

2. To receive and elect the Parish Council Vice Chairman for 2023/24

Cllr Peter Dinsdale was nominated by Cllr Thomas and seconded by Cllr Suttill. All voted in favour.

RESOLVED: Cllr Dinsdale was elected Vice Chairman for the year 2023/24.

8. To receive the Water Report from Jenny Walker and consider any financial expenditure.

Jenny Walker circulated the following report:

"The water supplied to the residents of Carlton is safe to drink, but there are continuing issues in the supply of the water, the treatment of the water to current standards, and the distribution to and within the village.

Water usage has remained at 55-60 cubes per day since the leak at a house in the village was stopped on 19th February this year. This usage is still higher than the expected 35-40 cubes per day, but no other leaks have been seen.

Following comments from Culligan some years before about the age of the equipment in the Water Hut, I was asked by the Parish Council at their meeting in early 2020 to investigate different companies to service and/or give their advice or recommendations and options to supply safe drinking water to the residents of Carlton.

I am summarising here the outcome of those investigations in 2020/2021.

Representatives of 9 different companies dealing with Private Water supplies and Water Treatment agreed to come and look at our System. After visiting the site, reports were provided by 8 of them, but only 3 were prepared to give us a quotation for their recommendations. These were Culligan, Daleswater and Yorkshire Water.

Mark Evans from Culligan sent us 3 different options and quotes in February 2020. The most practical option and the one he recommended, which was also the cheapest, was the option to replace the Filtration system.

Covid then arrived in March and it wasn't until October 2020 that Mark could make a presentation to a meeting with the Parish Councillors about his recommended new Filtration system and answered the Councillors' queries. Mark was asked about some specific additions to the System, and 6 weeks later he sent us a new quote with all the additional details separately itemised.

Daleswater visited after the first Lockdown and sent a report with a very high quotation figure in July 2020. Their two Directors were booked to come to a meeting with the Parish Councillors on 6th October 2020, but they backed out 2 days before and have not responded to queries since.

Phil Ward from Yorkshire Water visited Carlton in June 2020 and sent preliminary costings for 4 different options. Phil presented these 4 options to a meeting with the Parish Councillors in June 2021. At the meeting he was asked for more accurate figures. Phil visited Carlton again with some technical colleagues in August 2021 and sent us accurate quotes for 2 options in September 2021.

In October 2021, in planning for the service that year by Culligan, the Parish Council was reminded that some of the parts required were becoming obsolete and/or unavailable, but the service was able to be carried out that year.

The latest service was carried out by the Culligan engineer in March 2023, but not all the spare parts required were available. Following the service, a letter from the Service Manager at Culligan pointed out several problems with the equipment in the Water Hut and servicing it in its current state. Culligan recommended that the Water Treatment Plant should be replaced as soon as possible.

A meeting was held of the Water committee on 26th April to discuss the situation and resolutions were made to be acted upon and brought to this Parish Council meeting.

It was agreed that there are 3 main elements that produce safe water to supply to the village residents. These being:

the Source and Supply of water to be treated,

the Treatment of the water – which should be to DWI (Drinking Water Inspectorate) 2016 regulations for Private Water Supplies, and

the Distribution after treatment to all the residents of Carlton.

It was agreed that full costings for these 3 elements should be made, from different appropriate companies, and that somebody with experience in this type of procurement and producing consistent comparisons between options and companies be approached to do this.

Costing will also need to be done of the ongoing annual costs associated with a new Water Treatment Plant, both to the council and therefore to residents versus the cost to residents for their water usage each year with Yorkshire Water.

It was stated that when quotes have been collated, the next steps will be agreed as to holding a village meeting and contacting governmental agencies for assistance.

I was asked to make contact again with Yorkshire Water, and I am able to report that Phil Ward and his team are willing to attend discussion meetings as requested, and to update their quote from September 2021.

Culligan are continuing to offer engineer advice and help with the functioning of the equipment in the Hut with which our water is being treated.

I am very grateful to the Parish Council for their support to ensure the ongoing supply of safe drinking water to the residents of Carlton."

RESOLVED: The Parish Council agreed the proposed actions of the water committee and thanked Andy Morson for agreeing to coordinate quotes.

Arising from the letter from Culligans was the fact that there is no First Aid Kit or eyewash station in the water hut. The Clerk informed the meeting of where to purchase these items.

RESOLVED: The Council instructed the Clerk to purchase a first aid kit and eye wash station

9. To consider the areas the areas of grass cutting required in the village to ensure that they are maintained

All areas are covered and are being maintained satisfactorily.

RESOLVED: Cllr Thomas to request Robin Houseman to cut the verges outside Hall Ing Cottage as and when required.
