Minutes of Meeting held on 12th May 2022

1. To receive Nominations and elect the Parish Council Chairman for 2022/23 and signature of Declaration of Acceptance of Office

Cllr Howard Thomas was nominated by Cllr Dinsdale and seconded by Cllr Suttill and all voted in favour.

RESOLVED: Cllr Thomas was elected as Chairman for the year 2022/23 and duly signed the Declaration of Acceptance of Office.

Cllr Thomas and the Clerk expressed thanks to Dawn Suttill for her service during her years on the council.

2. To receive and elect the Parish Council Vice Chairman for 2022/23

Cllr Peter Dinsdale was nominated by Cllr Thomas and seconded by Cllr Suttill. All voted in favour.

RESOLVED: Cllr Dinsdale was elected Vice Chairman for the year 2022/23.

7.4 Review of Policy for Storing Data

RESOLVED: The reviewed policy, circulated prior to the meeting was duly approved. This is to be uploaded to the website.

7.5 Other Matters Arising

The Clerk informed the meeting that she had received an email about a note left on a car windscreen at the top of the village regarding parking. It was agreed that whilst no one has the right to park outside their house on the road, that consideration should be given to permanent residents by holiday cottage owners and a polite request should be put in the newsletter accordingly.

RESOLVED: A plaque is to be put up by the new tree for the Jubilee – the clerk will circulate suggested wording accordingly.

8. To receive the Water Report from Jenny Walker and consider any financial expenditure.

Jenny Walker circulated the following report:

"The water supply to the residents of Carlton village continues to be safe to drink.

Usage has been maintained at 75-80 cubes per day since early March.

This increased usage was investigated by Raymond Brown and Pete Hill in early March and they found increased water usage in the top half of the village, but the source of this presumed leak has not yet been investigated further.

A new person has been identified who is insured to put in new stop-taps to water supplies for Carlton Parish Council.

A couple of residents at the top of the village are wanting to fit a new stop-tap connection to the Main pipe for their own personal domestic supply.

The water committee have agreed that if this work is carried out that Carlton would benefit by having an additional stop-tap at that site, and all parties will benefit by the sharing of the cost of digging the main hole in the road.

There will also be a new stop-tap at Melbecks Studio for the benefit of the village.

There has as yet been no further progress with future plans for the water supply to the 100 houses in the village and the treatment of the water to the standards required in 2022 and beyond.

A meeting will be arranged with the Environmental Health Officer at Richmond District Council, and with the engineer who has recently serviced and worked on the equipment in the Water Hut and knows the system and its problems but as he is not employed by Culligans, he will be an independent opinion."

Howard Thomas reported that Phil Fullerton has been in touch with Kim Nunn and they will be contacting the council if they wish to go ahead with the stop tap cover work.

RESOLVED: The council asked the Clerk to contact Marcus Metcalf (07764306621) as another possibility for fixing leaks.

9. To consider the areas the areas of grass cutting required in the village to ensure that they are maintained and receive an update on the Village Garden Sign

All areas are covered and are being maintained satisfactorily.

RESOLVED: Cllr Thomas to request Robin Houseman to cut the verges outside Hall Ing Cottage as and when required.

10. To receive an update on the registration of Parish land.

Howard Thomas informed the meeting that all the paperwork for the Declaration of Truth regarding the parish land had been submitted by McGarry's and we await further correspondence from them when the Land Registry have been in touch.

11.2 Proposed contributions from business properties towards the water supply

Contributions are outstanding from the following: Foresters Arms, Carlton Old Hall, South View and Barn Acre.

RESOLVED: The council asked the Clerk to ask the Foresters if they wished to offset their bill for the water against the cost of the water committee meal.

11.3 Consider and Approve the Parish Council Insurance Renewal

The renewal quote for 2022-23 is £524.16. This is £8 higher than last year and we are tied into a long-term agreement until 2025. However, I do believe that we are underinsured for the water plant. Whilst I understand that the council believes that nothing is likely to happen to the water plant, to be underinsured would be unwise in case the worst does happen. We are currently quoted for a replacement cost of £30,585 for the building and £52,712 for the contents. The last quote from Culligans was for around £66,000.

RESOLVED: The council confirmed that they wished to keep the buildings replacement at £30,585 but to request that the plant replacement cost be increased to £75,000. They instructed the Clerk to contact Zurich for a revised quote.

11.4 Certify Carlton Town Parish Council as exempt from external audit for fiscal year 2021/2022

RESOLVED: The council confirmed that Carlton Town Parish Council is exempt from external audit for the year 2021/22 as its annual turn-over does not exceed £25,000

11.5 To note that that Annual Internal Audit Report for 2021/22

The council noted the Annual Internal Audit Report for 2021/2022 included at page 4 of the Annual Governance and Accountability Return 2021/22 carried out by Frank Fletcher.
