### Minutes of Meeting held on 13th May 2021

The meeting was held in the Coverdale Memorial Hall and started at 7.55pm after the Annual Parish Assembly. The meeting was held in line with the government guidelines for social distancing due to the Coronovirus pandemic and a risk assessment and track and trace record were carried out accordingly.

### Those present

Councillors Howard Thomas, Raymond Brown, Peter Dinsdale, and Dawn Suttill and the Clerk, Marina Briggs, attended the meeting along with Jenny Walker from the Water Committee and 3 members of the community.

# 1. To receive Nominations and elect the Parish Council Chairman for 2021/22 and signature of Declaration of Acceptance of Office

Cllr Howard Thomas was nominated by Cllr Dinsdale and seconded by Cllr Suttill and all voted in favour.

RESOLVED: Cllr Thomas was elected as Chairman for the year 2021/22 and duly signed the Declaration of Acceptance of Office.

# 2. To receive and elect the Parish Council Vice Chairman for 2021/22

Cllr Peter Dinsdale was nominated by Cllr Thomas and seconded by Cllr Brown. All voted in favour.

RESOLVED: Cllr Dinsdale was elected Vice Chairman for the year 2021/22.

Cllr Thomas informed the meeting that Cllr Simpson had resigned from the council and thanked her for her years of service. A presentation of a voucher £50 to spend at the Foresters Arms was then presented to Mrs Simpson.

The Clerk informed the meeting that RDC and Democratic Services was leading the appointment of a new councillor and that a notice of election had been displayed and if less than 10 people had requested an election, then the position could be filled by cooption. The Clerk will circulate the next steps to the Councillors once the information had been received.

The Clerk therefore suggested the Council leave things as they are for now and this was agreed by the council.

# 9. To receive the Water Report from Jenny Walker and consider any financial expenditure.

Jenny Walker circulated the following report:

"14 months on and we are still under the strong effects of the Coronavirus pandemic. It has not helped us make progress with the upgrade of the supply and treatment of water to the 100 houses and few farms in Carlton, but we have stayed drinking safe water throughout.

#### Water Supply to the Hut

Tremendous rainfall in early November 2020 resulted in a very low supply of water getting to the Hut. This was found to be due to a landslip next to the Quarry face which had damaged and broken the earthenware pipe. A team of volunteers spent a cold and wet afternoon clearing the blockage and making the pipework continuous again, very grateful thanks to them.

This functioned adequately until the second half of April, when supply to the Hut again was poor, and was found to be due to a blockage at the area of the pipe which had been damaged in November. A temporary bypass was created with good effect, but for only 12 days when the pipe system blocked again and was rodded clear. A meeting of the water committee last Friday have agreed that the pipe in this area needs to be replaced from the Quarry face to the top manhole reservoir, and enquiries are being made of contractors to find somebody with the appropriate equipment to do this on such a precarious piece of land.

It was also agreed at that meeting that the Borehole pump should be serviced and cleaned, last done in March 2017, and Cumbrian Pumps have agreed to do that. Other remedial actions in the area at the Hut are also planned by the volunteers.

### Water usage and Leaks

Water usage was in the 50's at the beginning of the year. It rose to 60's during the extreme cold in January, and to the 70's and over 80 in early February. A tap near Orchard Cottage was the culprit. Water usage went down but was still in the 50-60's and a leak was seen in late April on

the track to farm buildings in the village. The owners repaired the leak, and usage fell immediately to early 40's where it now is.

### Discussions with different companies to upgrade the Water supplied to Carlton

Mark Evans from Culligan met the Parish Council on 19<sup>th</sup> October and explained his proposal to replace the current Filtration system. It is expected that this modern and up to date equipment will function much better than the current system of two Filters installed in 1998, a third Filter added in 2000 and a Borehole added in 2011 in attempts to improve the colour of the water supplied to the Village. Councillors asked questions about the proposal as presented and asked for additional equipment to be quoted for (Tannin filter, Remote alarm system, Generator for emergency power back-up). This information was sent to Councillors in December.

A meeting with Phil Ward from Yorkshire Water in November had to be postponed due to the second Lockdown, and again in January with the third Lockdown.

New dates have been requested and will be circulated to the Councillors to find a date for them to meet him, along with the members of the Water committee."

The Clerk confirmed that dates had now been circulated and a date would be agreed in the next few days for the Yorkshire Water visit.

Cllr Brown informed the meeting that Howard from Ken Rodney would be coming to look at the water pipe from the quarry face to the top manhole cover as a matter of urgency. It was agreed that since it was essential work, if it could be carried out easily by Ken Rodney there and then, that they should be instructed to do so, but if large scale digging and works was required, that a quote would be obtained.

# 10. To consider the areas the areas of grass cutting required in the village to ensure that they are maintained and receive an update on the Village Garden Sign

All areas are covered and are being maintained satisfactorily.

RESOLVED: Cllr Thomas to request Robin Houseman to cut the verges outside Hall Ing Cottage as and when required. Cllrs Brown and Dinsdale to cut the bottom of the village grass area.

# 11. To review the parish risk assessment, asset register, standing orders, financial regulations, GDPR data audit and records management policy

RESOLVED: These polices had all been circulated by the Clerk to the councillors prior to the meeting and all were approved.
