- iii. Planning

CB/18/01493/FULL Woodlands, 2 St Nicholas Close - Levelling of the ground for the placement of a new shed. Discussion re work having already been started; location is in the Tingrith Conservation Area; hedgerow has been replanted with plants, some inappropriate; gravel boards not in keeping; implications for other

conservation areas in CBC. Prior to the meeting, the CBC Planning letter and a draft letter opposing the application were circulated and it was proposed by Christine Schuster and seconded by Richard Stratford that the letter with some minor amends be sent from the Tingrith Parish Meeting (TPM) to CBC Planning objecting to the application. *Action: Christine Schuster to forward the final draft letter to the clerk to send to CBC Planning.*

CB/18/01652/OUT – Orchard House, 4 St Nicholas Close - erection of a single detached dwelling with attached garage, associated driveway, landscaping and tree work. The letter from Planning, CBC was circulated prior to the meeting. Raminder Singh addressed the meeting – key points: proposed dwelling location is at the bottom of a sloping garden; limited infilling within villages in the Green Belt is permitted, Orchard House is not within Conservation Area. The dwelling would be surrounded by high hedges/trees. Discussion followed about the need for access from the High Street, loss of trees. As no written proposal objecting to the application had been submitted prior to the meeting, it was agreed that individuals should submit their objections to planningcomments@centralbedfordshire.gov.uk.

iv Other – Highways

Parish Walkabout – Sandra Bradley and Clive Faine together with Lee Norris, Highways, CBC undertook the walkabout today and identified: blocked drain by bus shelter; pot holes in High Street + reappearance, road sweeping needed. *Action:* Clerk to enquire timeframe between marking of pot holes and filling in.
