Introduction and Context:

Welsh St Donats Community Council covers a large rural and agricultural area with approximately 210 dwellings in four hamlets, Welsh St Donats, Maendy, Tair Onen and Prisk, and part of Hensol Forest (managed by Natural Resources Wales). The Community Hall and Church in Welsh St Donats are the only community facilities. The precept for 20-21 is £7,000.00.

The Community Council is responsible for maintaining the following areas:-

1. Welsh St Donats

The pond and surrounding area, including a bench and hedges.

2. Ystradowen

The grass verge opposite the entrance to the Highgrove Estate.

3. Prisk

The triangle of grass at the entrance to Prisk and the Village Green, including a bench.

4. Maendy

The flowerbed at Maendy corner and a bench.

REVIEW OF s6 DUTY

What has worked well?

The Churchyard has been cut leaving a metre wide border around the boundary to encourage biodiversity. Prisk Triangle is cut after spring flowers have seeded. To be reviewed at AGM May 2022.

What have the barriers been?

Fly-tipping and littering remain a major local issue with little evidence that these issues are taken seriously by the Vale of Glamorgan Council. Welsh St Donats Community Council continue to monitor this and press for appropriate action from the Council.

What will we change?

We will continue to seek ways to increase biodiversity within the Welsh St Donats area.

After being notified of NRW Condition Assessment Report on SSSI Pysgodlyn Mawr (2014), the Community Council requested a site meeting with NRW to find out what steps had been taken to address the shortcomings identified in the Report and what the plan is for the future to preserve and enhance wildlife in the lake and surrounding areas. The meeting will take place on 26.5.21.

How and when will the s6 duty be monitored and the s6 plan reviewed? The Report will be reviewed annually at the AGM and a Report will be submitted to Wales Biodiversity Partnership (S6BiodiversityDuty@gov.wales) every three years. The next Report will be submitted in 2022.
