WELSH ST DONATS COMMUNITY COUNCIL CYNGOR CYMUNED LLANDDUNWYDD MINUTES OF COMMUNITY COUNCIL ORDINARY MEETING ON 17th May 2022

PRESENT: Councillors Emma Hall (in the Chair), Ann Thomas, Natalie Bosworth and County Councillor Michael Morgan

- **1.(1) PUBLIC FORUM:** The Clerk had not received any issues raised by members of the public for this item.
- 2. (2) RECEIVE APOLOGIES: Councillor Cheryl McNamee-Brittain
- 3. (3) DECLARATION OF MEMBERS' INTERESTS: None
- **4. (4) MINUTES AND AGENDA:** The minutes of meeting on 5th April 2022 and agenda for ordinary and AGM were approved and signed. Those Councillors present signed acceptance of office forms and Cheryl McNamee-Brittain would to sign at the next meeting. **ACTION:** Clerk to provide form for next meeting
- **5. (5) POLICE REPORT:** No member of the SW Police was available to attend. No crimes were reported in the WSD Community Council area in March or April. PCSOs Jen Alcock and Richard Davies hold monthly meetings at the Three Horseshoes (PSE) and it was agreed the Clerk should attend the next (27.5.22 at 4pm) to raise the issue that further police reports to community councils would include less detail.

ACTION: Clerk to attend meeting

6. (6) REPORT FROM COUNTY COUNCILLOR: The Chair congratulated Michael Morgan on his re-election.

Michael Morgan summarized the composition of the Vale Council (coalition) and his priorities for the next few years. These included pressing for road safety issues in the rural Vale and care for senior citizens in their communities. He also stressed that he is always available to respond to queries and concerns from residents.

Ann Thomas expressed disappointment that Cardiff now had extensive 20mph speed limits yet the Vale were not introducing the equivalent in rural villages, even where all that was required was to change existing 30mph limits to 20 mph which was surely not very expensive. She hoped that the three trials in Vale villages would soon lead to wider implementation and asked Cllr Morgan to keep pressing for action

Michael acknowledged that there is general lack of interest in becoming a community councillor and suggested an occasional meeting (possibly social) of the Community Councils in the PSE Ward to discuss this and other problems common to all.

He was unable to give any further information regarding planning application 21/01379/FUL The Quarries, Bonvilston, which is understood to be awaiting determination by the Planning Committee.

ACTION: The Clerk to monitor Planning Committee agenda

The Chair thanked him for his report. Michael Morgan left the meeting.

7. (7) MATTERS ARISING:

1. Vacancies on Community Council: the Clerk had posted advertisements (approved by the Council) on the website and noticeboard. So far two residents had requested further information. It was agreed to post a request for applicants on social media where groups existed and leaflet remaining areas. The wording was approved. The closing date for applications is 27th May.

ACTION: Clerk to arrange posts to be put on social media groups in Tair Onen, Maendy and WSD, remaining areas to be leafleted.

1. Possible Project: the Community Council is considering creating a circular path in Hensol Forest (near Heol y March) and over neighbouring land. This unregistered path is already in regular use but without a stile to cross a boundary. Establishing ownership of the boundary fence and approval of the path by NRW is required before the Community Council could provide funds for the stile.

ACTION: Natalie Bosworth to contact landowner to find out ownership of boundary fence. Approval of the path from NRW will be raised at a site meeting.

It was agreed the Clerk should contact a local naturalist to request some guided walks around the Hensol Forest over the summer.
