WELSH ST DONATS COMMUNITY COUNCIL MINUTES OF COMMUNITY COUNCIL MEETING ON 2nd July 2013

ITEM 3 (209) DECLARATION OF MEMBERS' INTERESTS None

ITEM 4 (210) The minutes of the meeting on 4th June 2013 were approved and signed.

ITEM 5 (211) POLICE REPORT Although Matt Smith could not attend the meeting he reported via email that there had been one incident on 1st May that is still under investigation involving an assault connected with road rage.

ITEM 6 (212) MATTERS ARISING

a) NRW Future Management of Tair Onen – Glyn Jenkins gave a short review of previous proposals to develop land in Tair Onen. Rhodri Traherne pointed out that LDP, shortly to be approved, would not permit any development on this site in the foreseeable future. He suggested, after consulting those in Tair Onen through Peter Castle, the Community Council might like to come up with proposals of what the community would like to see there.

Peter Castle had requested a meeting with Jane Hutt AM, Rhodri Traherne and Community Councillors, however it was agreed that after the NRW surgery held in June and assurances from Rhodri Traherne such a meeting would be premature.

b) Site Meeting at Watery Lane with Vale Highways – following this meeting in early June work had not been done as promised at the site meeting. Clerk to provide Rhodri Traherne with a summary of the meeting.

It was agreed that the next meeting would be in early August and, due to the availability of Councillors and Clerk, the meeting in September would be cancelled.

ITEM 7 (213) HIGHWAYS AND FOOTPATHS

As requested, the Community Council had been provided by the Vale with their policy for hedge trimming. Rhodri Traherne suggested that in the first instance the Community Council should coax landowners to trim overgrown trees and hedges before informing the Vale Council. Clerk to contact Watts and Morgan to find out the owners of the land between the Village Hall and the fork at Heol y March.

A map of potholes was sent in to Vale Highways.

Following a request by Natalie Bosworth, the Community Council will request that the verges in the area are not cut until after the spring flowers have died off unless visibility for vehicles is impaired. Spring was late this year and Highways will be asked to bear this in mind when scheduling the cutting of verges.

It was agreed that a letter of condolence would be sent to Natalie.

Vale Highways confirmed that resurfacing was scheduled at the end of August on the A4222 between Maendy and Ystradowen and the narrow lane between Welsh St Donats and

Aberthin.

ITEM 8 (214) REPORT FROM RHODRI TRAHERNE Rhodri reported that CRC funding was under threat but hoped funding would continue.

Road signs installed each end of Catreglas Farm Lane to try and discourage larger vehicles using the lane were not entirely suitable and other options were being considered.

Rhodri confirmed that the Welsh Government ICT Grant could be applied for by Councils individually and not necessarily as part of a package..
