# WELSH ST DONATS COMMUNITY COUNCIL MINUTES OF COMMUNITY COUNCIL MEETING ON 7<sup>th</sup> March 2017

**PRESENT**: Councillors Graham Duffield (in the Chair), Bill Fawcett, Emma Hall, Andrew Foyle, Nick Craddock and Ann Thomas. Members of the public: Rosie Hall and Christine Evans

- 1 (875) PUBLIC FORUM: Christine Evans wished to make the Council aware that she had been visited by two PCSOs recently regarding a alleged damage to a rotten gate. Nick Craddock (as a resident) reported that three residents of Heol y March had been interviewed by SW Police about allegations made against them which had proved unfounded. He wished to have it recorded that this was deeply upsetting to all those involved.

- **3 (877) DECLARATION OF MEMBERS' INTERESTS:** Nick Craddock declared an interest in Hendrewennol and was absent for any discussion.

- **5 (879) POLICE REPORT:** No one from SW Police was available to attend the meeting. PC Mark Goulding sent a report by email as follows:

05/02/2017 Theft from a motor vehicle – Hensol (Psygodlin mawr) Fishing equipment stolen from car. No lines of enquiry. Forensics negative.

Two matters of note; a suspicious vehicle seen parked up at Hendrewennol. Five occupants dressed in black entered farm with a reported banner and were disturbed by Farm hand and left scene. Enquiries on going, if anyone knows of this incident or vehicle please contact me soonest.

Secondly a number of sheep have been killed in separate incidents between Aberthin and Ystradowen over the last few months, SW Police have reported one member of the public for sheep worrying offence, and is aware of a loose dog seen around watery lane.

SW Police would be grateful if the Council could remind the local communities to keep their dogs on leads when around domestic stock especially now with lambing season.

Councillors expressed regret that a member of SW Police was not present at the meeting residents had raised issues and it would have been helpful if someone had been there to respond. It was agreed to inform him of this was so.
