# WELSH ST DONATS COMMUNITY COUNCIL MINUTES OF COMMUNITY COUNCIL MEETING ON 4<sup>th</sup> April 2017

**PRESENT**: Councillors Graham Duffield (in the Chair), Andrew Foyle, Nick Craddock and Glyn Jenkins. Members of the public: Christine Evans

- **1 (893) PUBLIC FORUM:** Christine Evans informed members of the alleged damage to a gate at Hendrewennol.
- **2 (894) RECEIVE APOLOGIES:** Councillors Peter Castle, Bill Fawcett, Emma Hall, Ann Thomas, County Borough CouncillorRhodri Traherne and PC Mark Goulding.
- **3 (895) DECLARATION OF MEMBERS' INTERESTS:** Nick Craddock declared an interest in Hendrewennol and was absent for any discussion.
- **4 (896) MINUTES AND AGENDA:** The minutes of the meeting on 7<sup>th</sup> March 2017 and agenda for current meeting were approved and signed.
- **5 (899) POLICE REPORT:** No representative from SW Police was available to attend the meeting. It was agreed to request the presence of PC Mark Goulding to the next meeting and AGM on 9<sup>th</sup> May.
- PC Mark Goulding sent a report by email as follows:
- 1. As reported to the Council on 6th December 2016, incidents involving damage to signage caused by a collision, a fuel truck causing an obstruction, a damaged gate and unfounded allegations made about a resident.
- -The damage to the Road sign was recorded as a damage only road traffic collision, involving a delivery van and it is for the insurance companies to take the matter further should the loser wish. The Police occurrence has been closed.
- -Fuel truck was supplying fuel for local property heating system, and was causing an obstruction for other road users. Roads users became irate and were abusive, matter resolved itself when truck left. No details known of abusive third parties. Information only. Occurrence closed as 'anti social behaviour'
- -Report of criminal damage to farm gate unable to show an intentional or reckless act to cause damage. The gate was in poor condition and any lawful use of this gate could have caused it to break. No further action and occurrence closed
- 2. As reported to the Council on 7th February, an historical sexual assault in Hensol Forest block, reported to you in January.
- -Investigation continues.
- 3. As reported to the Council on 7th March, separate incidents in which sheep have been killed between Aberthin and Ystradowen.
- -One person has been reported for summons to court for 'Sheep worrying'. Cage trap has been set up in local garden for wandering collie dog.
- 4. As reported to the Council on 7th March, a suspicious vehicle parked at Hendrewennol involving five occupants and reported banner.
- -Vehicle was a rental linked to a number of renewable energy companies, no direct link to Hendrewennol. No offences disclosed occurrence closed.
