# WELSH ST DONATS COMMUNITY COUNCIL MINUTES OF COMMUNITY COUNCIL MEETING ON 5<sup>th</sup> September 2017

**PRESENT**: Councillors Nick Craddock (in the Chair except for item 6.1), Glyn Jenkins, Peter Castle, Ann Thomas, Graham Duffield, Andrew Foyle and Emma Hall (in the Chair for item 6.1). Members of the public: Christine Evans (Heol y March), Charlie Reynolds (Ty Cerrig), Charles Keen, Thomas Smith and Scott Lewis (Hendrewennol) and Bridget and Joseph Craddock (Ffald-Wen).

- 1 (80) PUBLIC FORUM: Christine Evans noted that noise and traffic from Hendrewennol had been greatly reduced since the end of the school summer holidays. Bridget Craddock had concerns over the issue of a Temporary Event Notices (TENs) for the expected forthcoming Halloween events at Hendrewennol. She was particularly concerned that residents should be involved in plans for the flow of traffic during the events so residents knew how to access their properties. All those present were given an opportunity to speak in the forum but no-one else wanted to speak.
- **2 (81) RECEIVE APOLOGIES:** PC Dan Rees of South Wales Police and County Councillor Michael Morgan.
- **3 (82) DECLARATION OF MEMBERS' INTERESTS:** Nick Craddock declared an interest in Hendrewennol and Emma Hall declared an interest in the planning application for Glanffawydd, Welsh St Donats. Both signed a proforma and stated that they would leave the meeting for any discussion.
- **4 (83) MINUTES AND AGENDA:** The minutes of the meeting on 8<sup>th</sup> August 2017 and agenda for current meeting were approved and signed.

### 5. (84) POLICE REPORT:

No member of the Police was able to attend. There were no crimes in the Welsh St Donats area in August

# 6 (85) MATTERS ARISING:

(1) Hendrewennol: Nick Craddock left the room and Emma Hall took the Chair. Ann Thomas had had a phone conversation with Justina Moss at the Vale Council Enforcement Unit regarding the Inquiry Report. Ann understood from their conversation that Justina felt there had been flaws in both the Inquiry Report and the process of the Inquiry, and also that the reasoning behind the decision had been weak. Although the Vale Council had felt there were concerns in the quality of the decision, it had decided not to pursue the matter further. Regarding further events at Hendrewennol, Ann Thomas concluded from her conversation with Justina Moss that activities ancillary to fruit picking, as described at the Inquiry, were permissible. It was agreed that next year any activities falling outside these parameters would be noted.

Ann then considered the possibility of further action by the Community Council. The decision could not be changed, but a complaint about procedural issues could be submitted. It was agreed that any further action should be at the request of residents of Heol y March, who could also express their concerns directly to Justina Moss at the Vale Council.

It was agreed to leave Hendrewennol on the agenda for the next meeting.

Regarding Bridget Craddock's concerns over vehicle access during events, it was agreed to request SW Police to involve residents in plans for traffic arrangements and management. Glyn Jenkins had drafted a letter regarding wastewater from the café at Hendrewennol. It was agreed to consider this at the next meeting.

At this point it was agreed not to pursue whether the residential caravan at Hendrewennol had authorisation from Vale Planning.

**Action:** Councillors to monitor activities at Hendrewennol, which would remain on the agenda and wastewater from the café added. Clerk to contact Mark Goulding about traffic arrangements.

The Chair returned to the meeting.

(2) Tair Onen: There had been no further meeting of residents at Tair Onen so there was nothing to report. However concerns over the visibility from the bus shelter for those hailing buses from the Cowbridge direction had become troublesome due to overgrown hedges and the position of the bus shelter. It was agreed to ask Vale Highways for a site meeting and the required vision splay for bus shelters.

**Action:** Clerk to contact Vale Highways for site meeting and vision splay requirements There had been no response on policy regarding the use of firearms near a footpath from SW Police.

Action: Clerk to request again.

Regarding the concerns of Tom Williams, 3 Tair Onen, over concerns of encroachment on to rights of way as recorded at the last meeting, Glyn Jenkins had visited the site and had informed Mr Williams that it was not appropriate for the Community Council to become involved.

(3) Castell Talyfan: The Vale Council Rights of Way team had taken this up and would report back when a decision had been made as to how to approach this and other issues.

Glyn Jenkins had noted that an article printed in the Gem (10.8.17, page 8), Creative Rural Communities (CRC) were interested in bringing business into rural areas. It was agreed that this might be a suitable item for the Community Liaison Committee (CLC).

**Action:** Clerk to put on agenda for next meeting.

**(4)** Co-option of Councillor: To date there had been no response from anyone in Highgrove to the mailshot to all residents asking for anyone interested in joining the Community Council to contact the Clerk. To give more time for responses, it was decided to postpone any further discussion to the next meeting.

**Action:** Clerk to put on next agenda.

(6) Cherry Orchard Farm. There had been no response from the Enforcement Unit regarding the residential caravan. Glyn Jenkins would check to see if it was still there and report back. Action: Glyn Jenkins to check if caravan still on site.

**7. (86) REPORT FROM COUNTY COUNCILLOR MICHAEL MORGAN:** No report. Michael Morgan was unable to attend the meeting.

#### 8. (87) HIGHWAYS AND FOOTPATHS:

Andrew Foyle raised the proposed improvements to the footway between Ystradowen and Aberthin on the A4222 which had funding from Bellway Homes under an s106 agreement and for which we had no further information.

Action: Clerk to contact Vale Council and copy to Michael Morgan.

Glyn Jenkins raised concerns that when the Vale Council had to cut hedges growing over the highway, where the landowner had failed to do so, that the cost should not be met by the Vale Council and the tax payer, but that costs should be recovered from the landowners.

Action: Clerk to add to next agenda.

### 9. (88) REPORTS FROM REPRESENTATIVES:

Ann Thomas had attended a Charity Trust meeting and reported that there had been an increase in student grant applications.

It was agreed that the Clerk should apply to the Trust for a replacement bench at Prisk Village Green. It was agreed that quote from Greenventure Lawn and Weed (£445.00) to purchase and install a bench should be included.

It was noted that the possibility of providing funds to build a play area at the WSD Village Hall had been raised with the Trust.
