# WELSH ST DONATS COMMUNITY COUNCIL CYNGOR CYMUNED LLANDDWUDD MINUTES OF COMMUNITY COUNCIL MEETING ON 4th October 2022

**PRESENT:** Councillors Emma Hall (in the Chair), Natalie Bosworth, Nigel England, Kay Davies and Tim Rich.

- **1.(94) PUBLIC FORUM:** No member of the public was present.
- **2. (95) RECEIVE APOLOGIES:** Councillors Cheryl McNamee-Brittain, Philip Popp, Ann Thomas and County Councillor Michael Morgan. The Chair welcomed Tim Rich to the Community Council.
- **3. (96) DECLARATION OF MEMBERS' INTERESTS**: Nigel England declared a personal interest in the pre-application for Three fishing lakes and associated works Pant Wilkin Stables Aberthin Cowbridge Tim Vaughan Racing. He also declared a prejudicial interest in planning applications 2022/00197/FUL and 2022/00198/FUL and was not present for any discussion.

**ACTION:** Add to online register

- **4. (97) MINUTES AND AGENDA:** the minutes meeting on 6<sup>th</sup> September and the agenda were approved and signed. Tim Rich signed an acceptance of office form. It was noted that the next meeting had been changed to 1.11.22. It would be decided shortly if this should be held remotely.
- **5. (98) POLICE REPORT:** In August there had been one reported crime, damage to a vehicle in Welsh St Donats (no suspects identified), and in September one dwelling burglary in Maendy (a person arrested and enquiries ongoing). It was noted that emails scammers are targeting T & C Councillors, these should be reported to report@phishing.gov.uk
- **6. (99) REPORT FROM COUNTY COUNCILLOR MICHAEL MORGAN:** Michael was unable to attend the meeting so emailed his report (copy attached). It was agreed that Tim Rich should seek the views of those residents in Highgrove and Sandy Lane on 20mph speed limits.

# 7. (100) MATTERS ARISING:

**1. 20mph speed limit for Welsh St Donats Village** – no response had been received from Emma Reed or Bronwen Brooks to our request for a reduction from 30mph to 20mph speed limit in the village.

**ACTION:** Clerk to follow up cc Michael Morgan

**2. Consider request to reinstate Churchyard maintenance grant** – after lengthy discussions it was **RESOLVED** (proposed by Chair, seconded by Natalie Bosworth) to

reverse Resolution 2 of 8.6.21 and reinstate the grant for Churchyard maintenance. It was agreed that in the first instance a grant of £600 would be paid in November (subject to available funds) and reviewed when the precept for 23-24 is set in January.

**3. Ty Cerrig Christmas Trees one way route**– it was agreed that, at the suggestion of a resident of Heol y March, the voluntary one way route for shoppers at Ty Cerrig Christmas Trees should be reversed to avoid traffic exiting from Heol y March at the blind junction with the Tair Onen and WSD to A48 lanes.

**ACTION:** Clerk to contact Highways, cc Michael Morgan

**4. Local Community Power** – Philip Popp was unable to attend the meeting but would be forwarding information to Council Members for future discussions.

# 8. (101) HIGHWAYS AND PUBLIC RIGHTS OF WAY:

- **1.Informal path in Hensol Forest:** Jonathan Price (NRW) and Andy Briscombe (Vale PROW) would be having a site meeting to discuss the possibility of making this a permissive right of way and will report back to the Community Council. The Community Council has requested that a member of the Council is present at the site meeting. **ACTION:** Clerk to follow up request
- **2. Japanese Knotweed on footpath 12:** neither NRW or the Vale Council are obliged to control Japanese knotweed on private land, it is the responsibility of the landowner. It was therefore agreed that an informal approach should be taken to make the landowner aware of the growth.

It was noted that the dead Ash tree in the field next to Vale View had been removed on 22.9.22.
