WELSH ST DONATS COMMUNITY COUNCIL CYNGOR CYMUNED LLANDDWUDD MINUTES OF COMMUNITY COUNCIL MEETING ON 4th July 2023

PRESENT: Councillors Natalie Bosworth (in the Chair), Kay Davies, Cheryl MacNamee-Brittain and Emma Hall. County Councillor Michael Morgan and a member of the public from Hensol, Pontyclun.

- **1.(247) PUBLIC FORUM:** The member of the public present had received a response from NRW (copy forwarded to Council members) regarding changes to the lakeside surrounding Pysgodlyn Mawr in Hensol Forest. In the speaker's view the response fell short of providing satisfactory answers to the issues raised and he informed the meeting he would be taking his concerns to the next level. The resident urged the Community Council to support him in seeking full justification for the actions taken by NRW.

- 3. (249) DECLARATION OF MEMBERS' INTERESTS: None
- **4. (250) MINUTES AND AGENDA:** the agenda and minutes of the ordinary and agm meetings on 9th May were approved and signed.
- **5. (251) POLICE REPORT:** There had been no reported crimes in Welsh St Donats ward in May.

It was noted Cuppa with a Copper has returned to the Three Horse Shoes Pub, Peterston on the $4^{\rm th}$ Friday of the month

6. (252) REPORT FROM COUNTY COUNCILLOR MICHAEL MORGAN:

20mph roll out for the Vale: Vale residents have been notified through the press of the roll-out and exceptions. It appears that the speed reduction for Welsh St Donats is not included in the roll out. Michael Morgan will be taking this up with the Vale Council. It was agreed that residents of Welsh St Donats should be informed of this by WhatsApp suggesting they contact Michael Morgan, if they wish, expressing their concerns. The Community Council would also do so.

ACTION: Clerk to draft letter and Chair send WhatsApp.

Issues at Psygodlyn Mawr raised with NRW: Michael Morgan has agreed to take the matter up. NRW response forwarded.

Regarding the access on to the A48 from Tair Onen, it was noted that the Vale Council did not consider the junction on the A48 currently justified improvement unless circumstances changed.

- **4. Disposal of dog waste:** it was agreed to remove this from the agenda and revisit if the problem persists.
- **5. Mirror at junction of A4222 and Trehyngyll lane:** the Vale Council had misunderstood the request was for a mirror and had responded refusing traffic calming measures, a further response is awaited.

8. (254) HIGHWAYS AND PUBLIC RIGHTS OF WAY:

1. Access to paths at Pysgodlyn Mawr, Hensol Forest: this had been discussed at the last meeting and a response had been proposed but not actioned. Comments made in the public forum were discussed and it was agreed that NRW's response to the speaker had not resolved all the issues he raised. A letter to NRW outlining the views of the Community Council would be drafted and Jane Hutt AM and Michael Morgan would be copied in.

It was also agreed that residents in Tair Onen and Welsh St Donats should be consulted on changes at the Lake through WhatsApp and any comments forwarded to Michael Morgan.

ACTION: a draft to NRW would be circulated for approval and WhatsApp groups in Tair Onen and Welsh St Donats notified.

Swing Gate for informal path, Hensol Forest: the approved swing gate had not been installed to date.

ACTION: Clerk to follow up with PROW
