# WELSH ST DONATS COMMUNITY COUNCIL CYNGOR CYMUNED LLANDDWUDD MINUTES OF COMMUNITY COUNCIL MEETING ON 7th November 2023

**PRESENT:** Councillors Natalie Bosworth (in the Chair), Tim Rich, Philip Popp, Kay Davies, Emma Hall, County Councillor Michael Morgan and two members of the public.

- **1.(318) PUBLIC FORUM:** Neither member of the public present wished to speak and both left the meeting following agenda item 6. A request to record the meeting was denied in line with Standing Orders 2018 (31) which requires prior consent.
- **2. (319) RECEIVE APOLOGIES:** Councillors Cheryl McNamee-Brittain, Ann Thomas and Nigel England.
- **3. (320) DECLARATION OF MEMBERS' INTERESTS**: Emma Hall declared a personal interest in boundary issues at the Wallage and Glanffawydd, Welsh St Donats and took no part in any discussion on the matter.
- **4. (321) MINUTES AND AGENDA:** the minutes of meeting 3<sup>rd</sup> October and the agenda were approved and signed.

# **5. (322) POLICE REPORT:**

1. South Wales Listens: it was agreed the Community Council should sign up for this new community messenger service.

No crimes were reported in Welsh St Donats ward in October.

# 6. (323) REPORT FROM COUNTY COUNCILLOR MICHAEL MORGAN:

Prior to the meeting Michael Morgan had circulated the Replacement Local Development Plan (RDLP) 2021-36 and noted that while there were no proposed sites planned for Welsh St Donats ward, there may be knock-on effects from proposals for small units in neighbouring communities. It appeared that there would be a corridor of development along the Vale railway line with improvements to the station at St Athan. Michael Morgan would continue urging for the provision of more affordable and retirement housing in smaller settlements.

Boundary Review: The Vale Council awaits a report.

20mph speed limit for Welsh St Donats: nothing further to report as yet.

Blocked culverts at Penffordd-fawr: these were being dealt with as a matter of some urgency and were in hand.

Boundary issues in Heol y March: there was nothing further to report.

The Chair thanked Michael Morgan for his report and he left the meeting.

**1. Future of the Village Hall:** Natalie Bosworth had attended a Village Hall Committee meeting on 2.11.23. Committee members are struggling to find volunteers to replace those standing down and this could result in the Hall closing. A letter is being sent to all residents in the ward to make them aware of the situation.

**2. Council administration:** it as agreed that the Clerk should continue to circulate all incoming emails to members of the Council (with the exception of advertising material and those concerned with the general administration of the Community Council) and consult One Voice Wales on anonymity issues.
