# WELSH ST DONATS COMMUNITY COUNCIL CYNGOR CYMUNED LLANDDWUDD MINUTES OF COMMUNITY COUNCIL MEETING ON 5th March 2024

**PRESENT:** Councillors Natalie Bosworth (in the Chair), Kay Davies, Nigel England and County Councillor Michael Morgan.

- **1.(389) PUBLIC FORUM:** No member of the public was present.
- **2. (390) RECEIVE APOLOGIES:** Councillors Ann Thomas, Cheryl McNamee-Brittain, Tim Rich, Philip Popp and Emma Hall
- 3. (391) DECLARATION OF MEMBERS' INTERESTS: None
- **4. (392) MINUTES AND AGENDA:** the minutes of meeting 6<sup>th</sup> February 2024 and the agenda were approved and signed.
- **5. (393) POLICE REPORT:** no crime report had been received for February.
- **1. Neighbourhood Watch Scheme:** Jane Wattleworth, chair of the Vale watches, had been contacted and a response is awaited.

PCSO Richard Davies had been asked, in a slot prior to our February meeting, to give us more information about Neighbourhood Watch schemes. This had worked well and we were able to ask more general questions. It was agreed that a member of SW Police should be requested to attend a meeting once or twice a year.

It was noted that Police would be patrolling the picnic area regularly and 'Cuppa with a Copper' had a new time and place.

### 6. (394) REPORT FROM COUNTY COUNCILLOR MICHAEL MORGAN:

**Council Tax:** a significant rise in tax is to be expected to cover the increasing costs of services. The tax rate will be set on 6<sup>th</sup> March 2024.

**Retention of Convex Mirror at Park Newydd:** Michael Morgan had received a response (and will copy in to the Community Council) in which the Vale Council had refused to replace the unauthorised broken mirror as there was no evidence of any road traffic incidents occurring at the junction. It was suggested the Community Council could install and maintain a mirror.

**Signage for Tair Onen:** Michael Morgan awaits a response to our request for a site meeting.

The Chair thanked Michael Morgan for his report and he left the meeting.

#### 7. (395) MATTERS ARISING:

**1. New Management of the Village Hall:** issues regarding the transfer had mostly been address. The website would be updated with information for booking and contact details. It was confirmed that the rent for Community Council meetings would remain at £25 per meeting. The leak in the roof had been repaired and Nigel England will be

meeting Kevin Parsons of Vale Council Public Buildings to discuss further repairs. Nigel England put in a request for any residents to join him and create a team to manage the Village Hall.
