CONSULTATION M4/A48 LINK: The Vale Council are seeking your views on the possible highway options. The consultation runs to December 23rd 2020. For information on the study and online feedback form, go to:- www.valeofglamorgan.gov.uk/M4|34toA48.

At our Community Council meeting on 6th October, County Councillor Michael Morgan told us that the Vale Council is making every effort to make the consultation as inclusive as possible. He urged residents to respond with their views.

FROM THE POLICE: PCSO Davies was not able to join our last meeting so sent in a report by email. There had been a theft of a watch in the Vale of Glamorgan Hotel (no suspects identified), a fire resulting in a burnt out vehicle on the Pendoylan road (the Fire Service attended) and an attack on a horse by a dog in Cwm Farm Lane (dog owner spoken to and advice given).

HIGHWAYS: The Community Council continues to report blocked culverts and potholes to the Vale Council. It is also seeking advice from the Vale Council on the responsibility of landowners where dead or dying branches are hanging over the highway.

DEFIBRILLATOR FOR WELSH ST DONATS: The Community Council continues to explore the options and is getting further information from providers and other Community Councils.

FINANCES: Payment was made to Allan Williams for grass cutting in September and after getting a quotation from another contractor, it was agreed that Allan Williams offered the most cost-effective service and he would be awarded the contract for 2021.

FROM REPRESENTATIVES: Nick Craddock had represented the Community Council at remote meetings with the Vale Council on the M4/A48 Link and at a Community Liaison Committee meeting.

DOCUMENTS: The Community Council discussed and agreed to support changes to the Vale Council's Public Service Protection Order - Controlled Alcohol Zones. Comments have been submitted.

FROM VALE PLANNING:

A planning application for 20/01012 Tan Y Lan Cottage was discussed and comments submitted.
