Please note that following advice from One Voice Wales concerning public attendance at remote meetings, it was agreed to continue with current practice and request residents write in or email issues they would like raised at meetings. If you have any issues you would like raised at our next remote meetings, on  $6^{th}$  July, please inform the Clerk seven days before. The agenda will be posted on the website and notice board in the bus shelter at Welsh St Donats at least three days before meetings.

**HIGHWAYS AND FOOTPATHS:** the Community Council continues to pursue with Natural Resources Wales problems relating to the restoration of footpaths in the area of forest at Heol y March following recent tree felling operations. The condition of footpaths and stiles in other areas of the community has been raised with the Vale Council PROW and we await a response.

County Councillor Michael Morgan informed us that a trial 20mph speed limit in Aberthin and Peterston-super-Ely will be imposed. This will be funded by the Vale Council.

**FINANCES:** Payment was approved for grass cutting in May (£328.80). The Annual Return was completed and will be submitted to Wales Audit before June 30<sup>th</sup> and an internal auditor was appointed for 21-22.

**BENCH AT POND AND BUS SHELTER:** The bench at the pond has collapsed and the Community Council are looking in to replacing it. The Vale Council has been informed of the poor state of the bus shelter.

**REPRESENTATIVES:** Members of the Community Council joined Elizabeth Felton from Natural Resources Wales to discuss the Condition Assessment Report on Pysgodlyn Mawr. As this may be of interest to many residents, a summary of the site meeting is on the website.

**POLICE:** a breach of Covid regulations was reported in Welsh St Donats, however no breach was detected.

**SURVEY:** Public Health Wales have commissioned a survey to learn lessons from the community-led response during the pandemic. The survey is for volunteers who have supported their community or given up their time freely to help others during the pandemic to assess the community. ## PLANNING APPLICATION:

The application for 16/00335/FUL Castell Talyfan (Amended) is to be determined at a Vale Planning Committee meeting shortly. Representations will be made by a member of the Community Council.

Applications for Ty Isha, Seven Acre Lodges, Heol y March (21/00677/FUL), Pantwilkin Stables, Aberthin, Cowbridge and a pre-application consultation for Pantyffynnon Quarry were all considered and comments submitted to Vale Planning.

Planning application 21/00304/Ful for 8 Tair Onen was approved by the Vale Council.
