TOWN AND COMMUNITY COUNCIL ELECTIONS: Local elections take place in May and all residents in Welsh St Donats are eligible and welcome to stand for election. REPORT FROM MICHAEL MORGAN:

Rural Roads Policy: following a Cabinet meeting which took into account comments from the Scrutiny Committee and Michael Morgan, the Cabinet decided this would be "considered further by the next Administration as part of an authority-wide traffic management and road safety policy that linked with both the 20mph default speed limit and plans for greater active travel opportunities." Michael emphasised the community must ensure this is kept high on the agenda of the next administration.

Council Tax: the Vale Council has approved a rise of 2.9% in Council Tax **Elections:** Michael Morgan repeated his request that the Community Council should promote forthcoming elections and encourage local people to stand. "The Community Councils are essential to look after the best interests of local residents and to give a voice to their communities".
