5.2 Grantiau Blynyddol/ *Yearly Grants* - Cadarnhaodd RDJ fod £2,000 ar gael ar gyfer y grantiau blynyddol, a bod 5 sefydliad wedi cyflwyno ceisiadau. Ar ol ystyried yr holl geisiadau, penderfynodd y Cyngorhwyryr y canlynol/ *RDJ confirmed that we have £2,000 available for grants this year and that 5 organisations had applied.* The Councillors considered the applications decided the following:-

## 6. Eitemiau sefydlog/*Regular items*

6.1 Mynwent Minffordd *Cemetery* - Mae Hotchief wedi dechrau paratoi'r lluniadau CAD ar gyfer y fynwent. Mae'r goeden oedd wedi torri yn estyniad y fynwent hefyd wedi cael ei chlirio/ *Hotchief has started preparing the CAD drawings for the cemetery. The tree that had fallen in the cemetery extension has also been cleared.*

- 6.2 Parc Mileniwm/ *Millennium Park* - Cadarnhaodd RDJ fod yr ysgol wedi cysylltu ac wedi darparu cynllun iddi o'r ardal yn y parc hoffent ei defnyddio ar gyfer yr ysgol y goedwig. Adolygodd y Cynghorwyr y cynllun a chadarnhau eu bod yn hapus gyda'r lleoliad/ *RDJ confirmed that the school had been touch and had provided her with a plan of the area in the park that they would like to use for the forest school. The Councillors reviewed the plan and confirmed that they were happy with the location.*
- 6.3 Cae Cookes - Mae R&M Utilities wedi cytuno i rentu ardal barcio Cae Cookes am y swm a gytunwyd o £800.00 y mis am gyfnod o 5 mlynedd. Mae RDJ wedi bod mewn cysylltiad a chyfreithiwr i sefydlu Les rhwng CTP a'r Cwmni/ *R&M Utilities have agreed to rent the Cae Cookes parking area for the agreed sum of £800.00 a month for a 5 year period. RDJ has been in contact with a solicitor to set up a Lease between CTP and the Company.*
- 6.4 Cae Chwarau Minffordd *Playground* - Rydym wedi derbyn hysbysiad y bydd gwyl yn cael ei chynnal ym Mhorthmeirion dros yr haf, ac mae'n bosib bydd angen i Borthmeirion ddefnyddio'r ardal barcio wrth ymyl y parc fel maes parcio gorlif. Bydd SM yn cysylltu a RLL i wneud ymholiadau/ *We have received a notification that a festival will be taking place at Portmeirion over the summer months and it may be that Portmeirion will need to use the parking area by the park as an overflow carpark. SM will get in touch with RLL to make enquiries.*
- 6.5 Maes y Parc - Mae'r Clwb wedi derbyn grant ar gyfer y ffensio. Bydd y twrnamaint pêl-droed yn cael ei gynnal ar 30 a 31 Mai. Mae croeso i bawb fynychu a byddai gwirfoddolwyr hefyd yn cael eu gwerthfawrogi'n fawr/ *The Club has received a grant for fencing. The football tournament will take place on the 30th and 31st May. All welcome to attend and volunteers would also be greatly appreciated.*
- 6.6 Ffyrdd a parcio / parking and road - Cadarnhaodd RDJ ein bod wedi derbyn e-bost gan YGC ynghylch y groesfan sebra arfaethedig wrth ymyl y feddygfa. Roedd yr e-bost eisoes wedi'i anfon ymlaen at y Cynghorwyr ond, i ailadrodd, nid oedd YGC yn cytuno a'n pryderon am ddiogelwch. Cytunodd y Cynghorwyr y dylem ymateb eto gan nodi ar gofnod nad ydym yn cytuno ac ein bod yn dal i gredu y bydd problemau diogelwch ar y groesfan os bydd yn mynd yn ei blaen/ *RDJ confirmed that we had received an email from YGC regarding the proposed zebra crossing by the surgery. The email had already been forwarded to the Councillors but to repeat, YGC did not agree with our concerns about safety. Councillors agreed that we should respond again stating for the record, we did not agree with the proposal and that we still believe that there will be safety issues on the crossing if they go ahead.*

8.1 Ymgynghoriad Cynllunio: Rhif Cais - C26/0016/08/DT - The Eyrie, Penrhyndeudraeth, Gwynedd LL48 6DW *Planning Consultation* - Dim gwrthwynebiad/ *No objections*.

## **9. Eitemau i'w trafod/ Items for Discussion**

9.1 Mynwent Minffordd - Rheolau y fynwent/ *Mynwent Minffordd - Cemetery Rules* - Dywedodd RDJ fod CTP wedi derbyn rhai cwynion yn ddiweddar am few cwn yn y fynwent. Gofynnodd RDJ a ddylem ystyried diwygio polisi'r fynwent i wahardd cwn neu gyfyngu ar eu mynediad i'r fynwent. Cytunodd y Cynghorwyr y dylai pob ci gael ei gadw ar dennyn ac y dylid casglu a symud unrhyw few cwn. Bydd RDJ yn adolygu'r polisi ac yn ei ddiwygio yn unol a hynny. Gofynnodd AJ a allem gysylltu a Chyngor Gwynedd am arwyddion./ *RDJ advised that CTP had recently received some complaints about dog fouling at the cemetery. RDJ asked whether we should consider changing the cemetery policy to either exclude or limit dogs being allowed at the cemetery. Councillors agreed that all dogs should be kept on a lead and that all dog foul should be picked up and taken away. RDJ will review the policy and amend accordingly. AJ asked if we could contact Cyngor Gwynedd for signs.*

9.2 Sefyllfa Post/ *Royal Mail* - Sylwodd EW nad yw'r post yn cael ei ddsbarthu i Pant yn rheolaidd. Mae'n aml yn digwydd nad ydynt yn derbyn unrhyw bost o gwbl ar rai dyddiau. Mae'r Cynghorwyr yn ymwybodol, o'r newyddion, fod problem barhaus gyda

dosbarthu post. Cytunwyd y byddem yn ysgrifennu at y Post Brenhinol a Liz Saville Roberts i fynegi ein pryderon mewn ymgais i roi pwysau arnynt ynghylch y dosbarthu/ *EW has realised that post is not being delivered to Pant on a regular basis. There are often days when they do not receive any post at all. Councillors are aware from the news that there is an ongoing problem with post being delivered. It was agreed that we would write to the Royal Mail and Liz Saville Roberts to voice our concerns in an attempt to put pressure on them regarding delivery.*

9.3 Man gwefrio cerbyd trydanol/ *EV Charging Point* - Mae SM wedi bod mewn cysylltiad a Chyngor Gwynedd ynghylch cyllido pwyntiau gwefru EV yn Penrhyndeudraeth. Mae GC wedi cynghori nad ydynt bellach yn cyllido pwyntiau gwefrio trydanol newydd. Mae SM hefyd wedi cysylltu a drydanol lleol, a byddai gosod gwefrydd cyflym newydd yn costio tua £25,000/ *SM has been in contact with the Gwynedd Council about funding EV charging points in Penrhyndeudraeth. GC have advised that they are no longer funding new charging points. SM has also been in contact with a local electrician, and to install a new rapid charger would cost in the region of £25,000.*

9.4 Ebst gan PC Elin Owen - wal yn y parc/ *Email from PC Elin Owen - wall in the park* - Dywedodd RDJ, ar ol i'r Heddlu adolygu'r holl dystiolaeth, y penderfynwyd nad oedd y mater yn cwrdd a'r gofynion i fynd i'r llys. Mae'r mater wedi'i ddatrys trwy "*community resolution*" ac mae'r mater wedi cael ei gau. Dywedodd y Cynghorwyr eu bod yn siomedig am y penderfyniad./ *RDJ advised that, following the Police's review of all the evidence, it was decided that the matter did not meet the requirements to be taken to court. The matter has instead, been resolved through a "community resolution" and will be filed. The Councillors expressed their disappointment at the decision.*
